

#### **Domestic Fundamentals:**

- Most of the edible oils featured steady owing to lack of cues from international palm oil market and limited buying,
   Friday.
- Groundnut oil featured steady tone in today's session and quoted Rs 1025 per 10 Kg at Rajkot market. However, Groundnut oil ended with the significant weakly losses due to selling pressure and dull demand from repackers and wholesalers.
- CPO Kandla 5% featured steady to firm tone in expectation of better buying from Indian subcontinent ahead of Muslim
  festivities, which might support palm oil in the days ahead and normal demand from wholesalers in the cash market
  Moreover, depreciating Indian rupee against US dollar would make imports of edible oils costlier which support the
  sentiments.
- India's MMTC Ltd has imported 18,000 tons of (RBD) palmolein at \$851.5 per tons, including CIF for immediate shipment Reuters.
- Edible oil basket is expected to feature range bound to slightly firm tone in the days ahead due to slow soybean offloading from farmers and normal demand.

## **International Market Fundamentals:**

- Malaysian palm oil futures market was closed due to 'Wesak day'. However, market participants expect demand recovery ahead of the Muslim festivities and low CPO production, Friday.
- Reportedly about 50 cargo ships have been delayed in Argentina's Rosario region due to the strike by port workers over wages for the last 3 days.
- Indonesia has set its export tax for crude palm oil at 9 percent for June remained unchanged from last month. While,
   Malaysia set its crude palm oil export tax for June at 4.5 percent.

Outlook: Edible oil prices are expected to feature range bound to firm movement for the short term.
