

Domestic Fundamentals:

- Edible oil basket witnessed a weak tone tone in prices across the major cash markets on bearish cues from international palm oil market.
- As per Soybean Processors Association of India, India's soybean output may rise 2.4 percent to 12.98 million tons in the current oilseed marketing year. Meanwhile, estimated yields would be 1,079 kg per ha in 2013/14, down 8.9 percent from 1,185 kg per ha in 2012/13.
- Refined sunflower oil featured lower at Chennai market owing to limited buying at higher quotes and weak international sun oil market. As per the first advance estimates of Production of Oilseeds for 2013-14, kharif sunflower seed output is seen at 0.126 million tons in the 2013/14. However, last year sunflower production was 0.151 million tons.
- As per Dorab Mistry, palm oil imports for 2013/14 oil year seen at 8.3 million tons, against 8.35 million tons in 2012/13 as local buyers may turn to soy oil and sunflower oil to supply domestic refiners.
- Edible oil basket is expected to feature range bound in the days ahead due to harvest pressure and strong Indian rupee. However, concerns over crop conditions and normal buying may limit excessive losses.

International Market Fundamentals:

BMD Market ended slightly higher on supportive Malaysian palm oil exports figures for September. While, expectation of climbing palm oil inventories in South East Asian Counties limit gains. Exports of Malaysian palm oil products in September rose 2.1 percent to 1,530,292 tons from 1,498,755 tons shipped in August - cargo surveyor Intertek Testing Services.

Outlook: Edible oil prices are expected to feature range bound for the short term.
