

Domestic Fundamentals:

- Edible oil basket featured steady tone on need based demand. Meanwhile, mustard and coconut oil quoted slightly higher from previous day.
- According to the Central Organization for Oil Industry and Trade (COOIT), soybean yield seen at 837 kg per hectare and soy production is estimated at 10.2 million tons, down 4 per cent from the last year. Continues rains during late September over key soybean producing regions of Madhya Pradesh, Maharashtra affected the yield prospects and the bad quality of seed arrived in the market.
- Indian Government has revised the tariff value for of crude palm oil to US \$ 849 increased by US \$38 per tons and raised base import price on refined palmolein by \$31 per tons to US \$ 900 per tons. Moreover, USD 1,006 per toms sets as a new base import price for crude soybean oil.
- Mustard oil quoted higher at major cash market due to better buying and gains in the competing soy oil support the prices. However, higher sowing witnessed in the first week of sowing. As per Ministry of Agriculture, sown area for Rabi mustard seed stood at 14.08 lakh hectares as on 30 Oct. 2013, up 7.38 lakh hectares compared to the corresponding period last year.
- Edible oil basket is expected to feature firm tone in the near-term. While, higher Kharif oilseed arrivals may cap the excessive gains.

International Market Fundamentals:

Exports of Malaysian palm oil products for Oct. 1-25 rose 3.8 percent to 1,259,841 tons from 1,213,583 tons shipped during Sep. 1-25, cargo surveyor Societe Generale de Surveillance. (Reuters). Indonesia kept its export tax for crude palm oil unchanged at 9 percent for November – Ministry official.

Outlook: Edible oil basket is expected to feature firm tone in the near-term. While, higher Kharif oilseed arrivals may cap the excessive gains.
