- Oscillator RSI is in oversold zone.

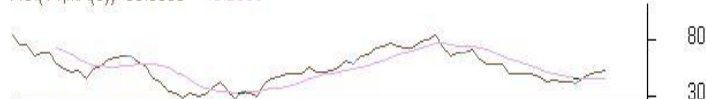
*The CPO prices are likely to feature range bound to firm tone today.*

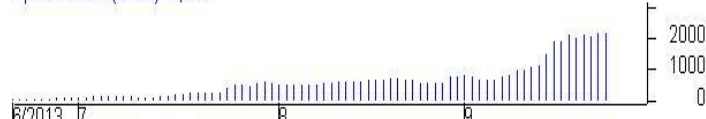
