

Pulses Domestic Fundamentals:

Looking into recent price hike in pulses and lower production estimate due to crop loss in producing region and lower monsoon rain forecast, Indian government is planning to import pulses through state owned trading firms such as MMTC to boost supplies and control rising prices of pulses. India may import pulses from Ethiopia and Tanzania owing to expected drop in output in Canada and Australia.

Prices of Pulses rises in Telangana due to increased cross border taxes imposed by Telangana and Andhra Pradesh on goods vehicles and decrease in average area of cultivation in the districts from 50,000 Hectares to 23,000 Hectares owing to poor rainfall. This year the districts received 30-40 percent deficit rain.

Pulses markets have passed through turbulent phase in last two weeks due to increased holding and Delhi govt.'s close eye on volatility of the market. Actually, prices started to get firmer with announcement of removing stock limit in Maharashtra, crop loss from unseasonal rains and increased quotes for imported pulses. Prices of pulses increase by Rs 300 to 400 per quintal in two to three days. Higher price for pulses started sending alarm bells to government and for checking food grains inflation and unexpected rise in pulses. Delhi government started sending suggestion to merchant association not to retain unnecessary stock and release them as soon as possible. Thus instruction acted well in favor of market and it decreased once again on higher release of stock. However, it is a temporary phenomenon and once the effect of higher release gets balanced, prices of pulses may move up once again.

New Moong in Indore region of M.P. starts hitting the local market and pressure is expected to build up by the end of May. New arrival would continue to flow into the market till June. Arrivals from Harda region is yet to start. New moong is being traded at Rs 7600 per quintal while old one attracted buyers at Rs 8400 per quintal. The gap between the two is likely to decrease with arrival pressure during end of May. Crop is in good condition and favorable weather in the growing region has heightened the yield prospects. Demand from local market seems normal. Prices of new and old crop are likely to trade in the range of Rs7000 to Rs 8000 per quintal respectively during peak arrival season.

Odisha government had set the production target of 0.587 MT of pulses in Kharif season. It includes 0.19 MT of Arhar, 0.15 MT of Mung and 0.176 MT of Biri. According to them pulses will be cultivated on about 0.965 million hectares with yield of 609 kg /Ha.

Maharashtra state govt. has removed the limit for oilseeds, edible oils and pulses on the recent recommendation by central govt. this week. The earlier limit for oilseeds and pulses were 200 tonne each under municipal limit and around 80 tonne elsewhere. It is being seen as a great relief for state trading community dealing with pulses and oilseeds. Despite removal of stock limit market may turn bullish as big traders may start cornering the stock to drag market in their own favor.

Pulses International Fundamental:

- Australian Chickpea is currently being planted and should be finished in the end of June. Weather condition is favorable and yield may increase this year as compare to last year. Harvest is set to begin after September. Demand and prices of Australian chickpeas increased due to crop failure in India. Australia exports around 95% of its chickpea crop where India, Bangladesh and UAE are its major export destination.
- **China for the second year in a row was net importer of Pulses.** According to the latest report compiled by STAT it imported 2.50 MMT of pulses in 2014 against 5.67 MMT in 2013. In 2014 it imported 8.17 MMT of pulses against export of 5.67 MMT. China was a net exporter of pulses until the 2013 calendar year. In 2012, China exported 3.67 MMT more pulses than it imported.
- **USDA's Commodity Credit Corporation released purchase** tender for 1000 metric tonne (MT) of yellow split pea for May -June shipment.
- **Field pea exports from France during the month of February** totaled 10,927 metric tons (MT) which is down by 19% from the 13,700 MT shipped in the month of January, and down 11% from the 12,470 MT shipped the same month last year. Shipments so far this season are down 36% at 83,555 MT. Most peas were shipped to European destinations, with Belgium the most important, followed by Switzerland and Italy. No field pea shipments were reported to Egypt or the Indian subcontinent.
