

Pulses Domestic Fundamentals:

According to IBIS (provisional data), import of pulses in the last week (13-July-19 July) was 134 Thousand tonnes at major ports in India, around 86% higher than previous week's (July 06-July 12), import of 72 thousand tonnes. Cow Pea, Masoor, Urad, Moong and Kidney bean were imported lower this week whereas Chana, Green pea, Tur and Yellow Pea were imported higher as compared to last week.

Area under Kharif pulses throughout the country stood 72.64 lakh hectares as on 24 July this year, around 50.6% higher when compared to the area sown during corresponding period last year which was 48.22 lakh hectares, according to Ministry of Agriculture.

Government is expected to procure 5000 metric tonnes of Tur from Malawi in order to regulate the domestic prices. Tur prices have been increased by around Rs 30 per kg as compared to the prices of last year across Delhi, Kolkata and Mumbai. According to a official, government will import Tur (Arhar) from Malawi, which will help prices to cool down and the procured pulses will be provided to states from where it will be made available to people at affordable price.

Area under Kharif pulses in Andhra Pradesh stood 0.28 Lakh Hectares as on 08 July this year, which is around 33% higher as compared to the area sown during corresponding period last year which was 0.21 Lakh hectares. The area of Green gram and Black gram has increased as compared to last year.

According to trader's feed back in Indore region of Madhya Pradesh, farmers have not received sufficient rainfall from last 15 days and if the situation continues to be the same farmers who have sown urad and moong may go for other crops. Urad and moong sown area till now in Indore region have increased by around 20-35% as compared to last year.

The government of Rajasthan has revised the stock limit to wholesalers from 250 tonnes to 400 tonnes. Of the 400 tonnes, a wholesaler may hold up to 200 tonnes of chana and 200 tonnes of other pulses. An official said warehouses registered with the Warehousing Development and Regulatory Authority (WDRA) would also be covered in the norm.

Government agency MMTC opened a tender to import 5000 tonnes of Tur, the offers must be of minimum 2500 tonnes and remain valid until 24th July and has to be shipped within 15 September at Mumbai or Chennai port. Tur can be imported from Myanmar, Mozambique and Malawi.

Pulses International Fundamental:

- **According to the local traders, no major damage occurred in Canadian Pulses** by frost and even the warm weather that followed has been ideal for crop development. They are estimating 3.75 million acres of the lentil crop, which is well above Statistics Canada's 3.35 million acre estimate and 3.9 million acres of peas, comprising three million acres of yellow and 870,000 acres of green peas. That is higher in line with Statistics Canada's 3.83 million acre estimate.
- **Australian Chickpea is currently being planted and should be finished in the end of June.** Weather condition is favorable and yield may increase this year as compare to last year. Harvest is set to begin after September. Demand and prices of Australian chickpeas increased due to crop failure in India. Australia exports around 95% of its chickpea crop where India, Bangladesh and UAE are its major export destination.
- **China for the second year in a row was net importer of Pulses.** According to the latest report compiled by STAT it imported 2.50 MMT of pulses in 2014 against 5.67 MMT in 2013. In 2014 it imported 8.17 MMT of pulses against export of 5.67 MMT. China was a net exporter of pulses until the 2013 calendar year. In 2012, China exported 3.67 MMT more pulses than it imported.
- **USDA's Commodity Credit Corporation released purchase tender** for 1000 metric tonne (MT) of yellow split pea for May -June shipment.
- **Field pea exports from France during the month of February** totaled 10,927 metric tons (MT) which is down by 19% from the 13,700 MT shipped in the month of January, and down 11% from the 12,470 MT shipped the same month last year. Shipments so far this season are down 36% at 83,555 MT. Most peas were shipped to European destinations, with Belgium the most important, followed by Switzerland and Italy. No field pea shipments were reported to Egypt or the Indian subcontinent.
