

Castor Daily Fundamental Report 19 Dec, 2015

Castor Domestic Fundamentals:

- Slight recovery in future market was seen on Friday. However, it is unlikely to affect cash market sentiment before December settlement. Weak spot demand and crusher's restricted buying interest at current level have weakened inner tonne in cash markets. Market may trade lower for week and recovery is expected in January-2016. Stock is ample and standing crop in Rajasthan, Gujarat, Telangana is in good condition. New arrival is expected one month earlier and may hit market by Feb end. Till then stockists would try to drag market up by restricting stock release. Stake holder should buy seed around Rs 3550 to Rs3650 per qtl and hold it for one and a half month. Production picture for 2015-16 would be clear in Global Castor Conference in Feb, scheduled to be held on 12 th Feb in Ahmadabad.
- Castor oil export recovers smartly last week due to lower prevailing prices in the market. India exported 10606.60 tonne castor oil at an ave price of \$1320.33 per tonne including premium grade oil too. China maintains its major buyers status once again buying 6389.06 tonne during the week ended13 Dec-2015. Second major buyer was Netherland who brought 1888.46 tonne oil. France, Thailand and Belgium too remain active last week. It is higher by 16.22 % from previous week.
- India exported 4140.29 tonne castor meal during week ended 13 th December-2015 at an ave FoB Of\$147.72 per tonne. The Highest and lowest prices were registered at \$107.62 & 272.91 per tonne. Major buyer was Taiwan and it brought2571.66 tonne castor meal last week.USA brought 9997 tonne meal during the same period. Other buyers were France and Japan who brought 205 and 223.22 tonne meal respectively. As seed price is ruling lower more export is expected in January-2016
- Agriculture statistics Division, DES has released its 1st Adv estimates of Production of food-grains for 2015-16 on 16.09.2015. It has estimated 19.44 lakh tonne seed production this year. The production target for 2015-16 has been fixed at 20.34 lakh ton. India has produced 19.63 lakh tonne castor seed in 2014-15 as per revised 1st Adv estimate. Private trade estimate for the year is much lower and is between 15 to 16 lakh tonne for 2015-16. However, it is too early to talk about the final size as sowing is just over.

International Market Update:

- China, Netherland and France remain active in castor oil market and they collectively brought 75 % of oil out of10606 tonne during the week ended 13 dec-2015. They brought an average price of41320 per tonne. The highest and the lowest quotes were registered at \$1594 & 41207 per tonne last week.
- India Castor oil in Rotterdam decreased from \$1540 to \$1535 per tonne in last one week and may trade up in the weeks ahead. It was being traded at \$1530 per tonne in (Dec, 1st week), 2015.

Domestic market Outlook: Market is likely to trade steady to slightly weak in the short term.
