

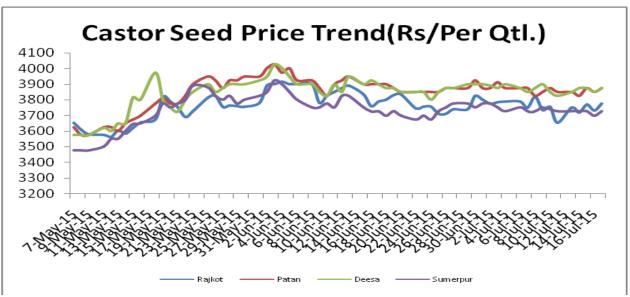
## Castor Weekly Report 20<sup>th</sup> July, 2015

#### Castor Domestic Fundamentals: -

- Castor seed cash markets extended its loss over previous week and down trend is likely
  continue as weather remains favorable for sowing in Gujarat and Rajasthan. Restricted
  buying from planters amid weak inner tone and sluggish overseas demand continued to
  weigh on market fundamental. More dip is expected in the weeks ahead as crop production
  prospect this year seems good so far.
- At arrival front, slight decline has been seen in all major markets during the second week
  of the month. It decreased from 47305 qtl. to 45916 qtl. during the week under review.
  Week on week basis total arrivals declined by 1389 qtl. However, modest increase was
  registered in Sumerpur, Rajkot, Patan and Deesa. No major change is expected at arrival
  front in the third/fourth week of this month.
- As sowing front, 0.55 lakh ha. area under castor seed has been covered till 9<sup>th</sup> July,2015.It is higher by 0.13 lakh ha. in comparison to last year till date. It was registered at 0.42 lakh ha. during the first week of July,2015.Despite smooth start area under castor seed coverage is lagging behind by 0.20 lakh ha in comparison to July,2013.
- Generally, under normal weather conditions castor area coverage ranges in between 10 to 11 lakh ha on all India level. This year too it may hinge in between 10 to 10.5 lakh ha. Good rainfall in the beginning of monsoon season in castor growing belt of Gujarat may encourage farmers to shift some castor area to other cash crop like cotton and sesame to some extent. Sowing is yet to pick up.
- Castor Oil (First Grade) FOB Kandla (Export) quote increased slightly last week from \$1260 to \$1265 per tonne. It is ruling lower by\$10 per tonne from mid June quote of \$1275 per tonne. It is lower by 16.28 percent from July,2014 quote. It was ruling at \$ 1471 per tonne in July,2014. More dip is expected in the weeks ahead as seed market remains under pressure.
- Local rates for oil in domestic market (Rs./M.T.) for comm. grade oil too has increased slightly from Rs 81000 to Rs 82500 per tonne during the week under review. However, it is ruling lower by 4.28 percent from the price realized in July,2014.it was ruling at Rs 86035 per tonne in July,2014.
- Agriculture statistics Division, DES has released Third Adv estimates of Production of food-grains for 2014-15 on 13.05 2015. It has revised castor production estimate at 18.24 lakh tonne, down by 87 thousand tonne to. In second Adv Est. Castor production was estimated at 19.11 lakh tonne. The minor decrease in third Adv. Est is mainly attributed to inclement weather and yield loss. India has produced 17.27 lakh tonne castor seed in 2013-14. Target for the year was 16.65 lakh tonne.

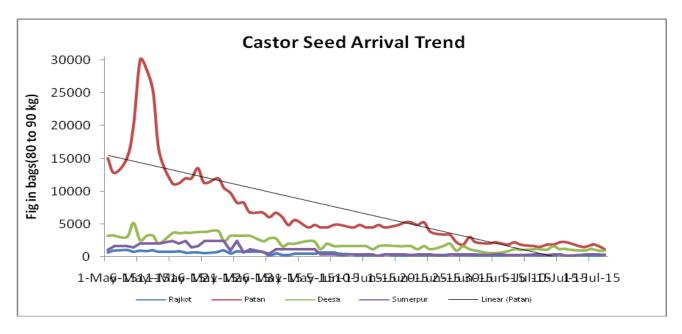


#### **Castor Seed Price Chart:**



Castor seed market trades range bound during last one month with variation of Rs 50 per qtl. However, overall tone remains bearish despite slight improvement in price during the week under review. Market participants expect more dip in the weeks ahead.

#### **Castor Seed arrival Chart:**

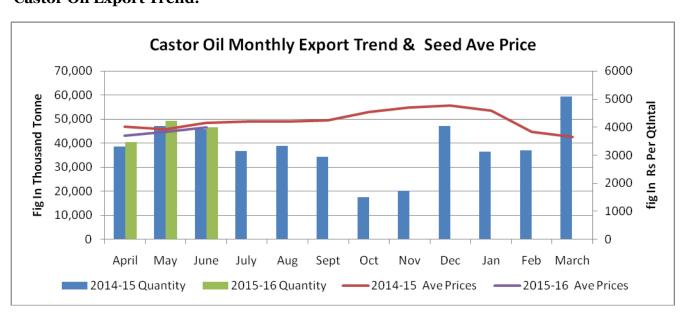

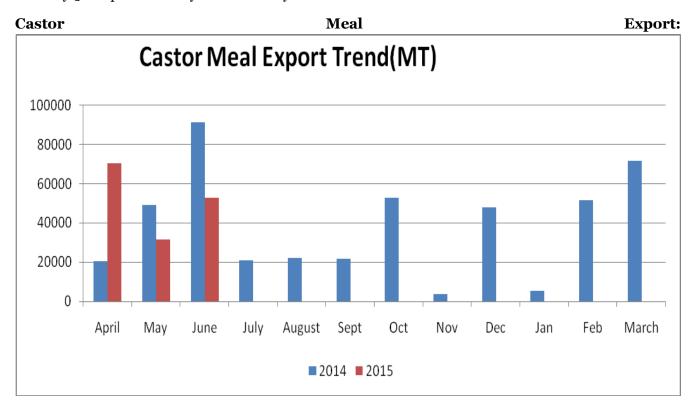
### **Castor Oil Export Trend:**

Castor meal export volume increased from May to June. However, it is lower than May, June- ,2014. As meal prices are ruling higher, export volume is expected to dip more in July,2015. FOB quotes for meal has increased slightly this week from \$108 to \$110 per tonne.

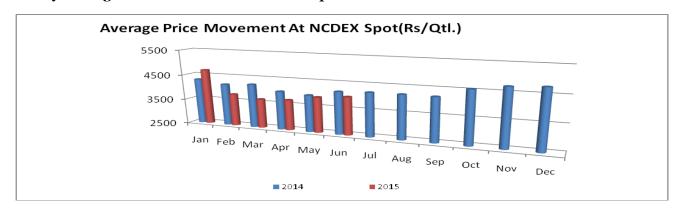

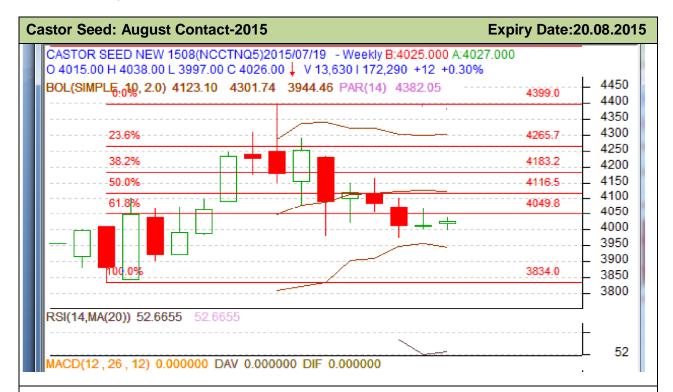
