

Highlights of The Week

Mixed trend were featured in Karnataka market on rising buying activities by the roaster and exporters during this week ended as on 27th April 2015. As per sources, Starbucks Corp has locked in prices on 70 per cent of 2016 coffee needs at "favorable" levels when compared to its 2015 coffee costs.

As per DGCIS report, India has received total coffee exports revenue around Rs. 659.05 crore which is in USD 105.53 million in March 2015 higher by 2.58% in Rs. and 0.22% in USD respectively against Rs. 642.45 crore and USD 105.30 million respectively in previous year during the same month. It stood at Rs. 4906.36 crore and the value in USD at 802.96 million since April-2014 to March-2015 up by 2.24 in Rs. and 0.52% when the value is counting in USD against last year revenue i.e. Rs.4799.10 crore and in USD 798.83 million in corresponding period of time.

In view of Traders, Robusta harvesting of 2014/15 is almost finished in the key growing regions of Karnataka, Tamil Nadu and Kerala. As per exporters, Arabica crop size of India is placed around 90,000 tonnes and Robusta crops at 2.3 lakh. While, Post Monsoon crop estimates for 2014-15 stood up by 8.70% to 331,000 MT followed by total Robusta estimates at 231,400 MT with an increase of 14.38% and Arabica estimates at 99,600 MT with a decline of 2.54% compared to last year output, as per the Coffee Board of India. Indian exporters are looking forward to some support from the Government in the forthcoming Export-Import Policy. Sources expects to increase the DEPB rates (Duty entitlement pass book) to around 2-3% from the current 1%. DEPB is an export incentive scheme of Indian Government provided to Exporters in India. DEPB rates are applied on the basis of FOB value or value cap whichever is lower.

In the recent forecast of Brazil crop, German coffee trader Neumann keeps Brazil coffee crop output higher at 45.3 million bags for 2015/16 season from its previous given forecast i.e. 45 million bags in August 2014. Brazil will commence its coffee harvesting in May 2015. He kept 2014/15 coffee crop size at 47.7 million bags. While, other sources like Ecom expects Brazil's crop production higher at 49 million bags followed by 32 million bags of Arabica crop and 17 million bags of Robusta crop for 2015/16 season.

As per Uganda Coffee Development Authority, Uganda shipped down coffee beans by 10.5% to 3.11 million bags in March from 3.48 million bags in the same period last year after dry weather conditions curbed output.



Exports and Imports of India

Provisional Indian green coffee exports is registered down by 18.45% to 86301metric tonnes from 1st January 2015 to 23rd April 2015 as compared to 105830 metric tonnes of previous year exports during the same period of time. India re-exports maximum Instant type of coffee which is recorded down at 18.45% to 24355 metric tonnes in this year during 1st January 2015 to 23rd April 2015 from preceding year instant coffee volume i.e. 15141metric tonnes. Total provisional exports of Arabica parchment, Arabica cherry is placed down by 43.09% to 15639, 35.67% to 5170 metric tonnes respectively against last year exports volume i.e. 27483 metric tonnes, 8037 metric tonnes respectively in the same period of time.

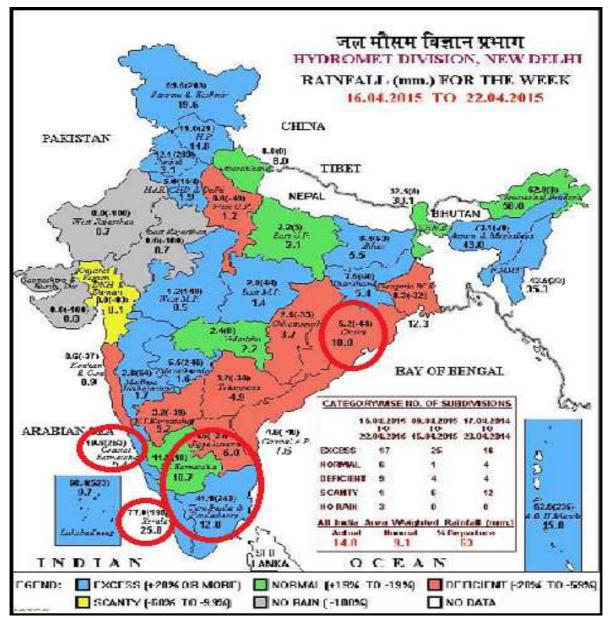

- An upper air trough runs from Telangana to extreme south peninsular India and extends upto 1.5 km above mean sea level.

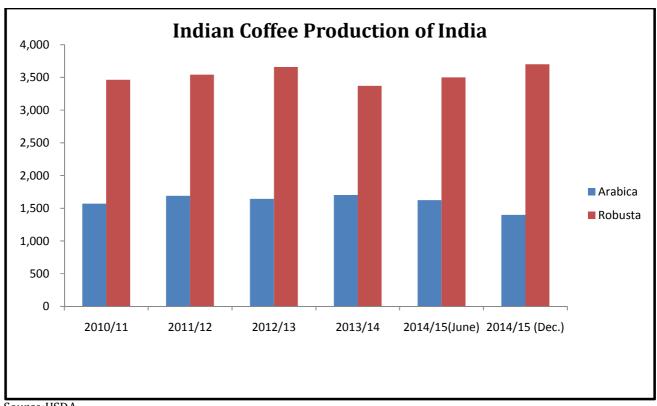


Domestic Crops Condition and Production

According to USDA report, Indian coffee production is likely to go up slightly by 0.49% to 5100 thousands 60 kg-bags for 2014/15 against 5075 thousands bags in 2013/14. Arabica coffee crops is expected to decline by 18% to 1400 thousands bags (60 kg bags) from 1703 thousand bags in 2013/14 on the back of adverse weather condition while Robusta coffee crop in 2014/15 may touch higher level of 3700 thousand bags with an increase by 10% against last year crop size i.e. 3372 thousand bags in 2013/14 due to good crop yield.

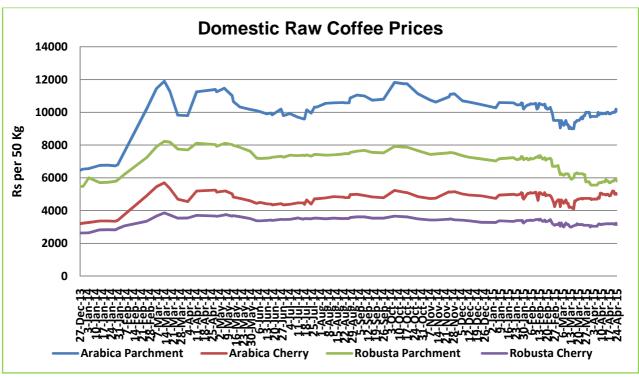

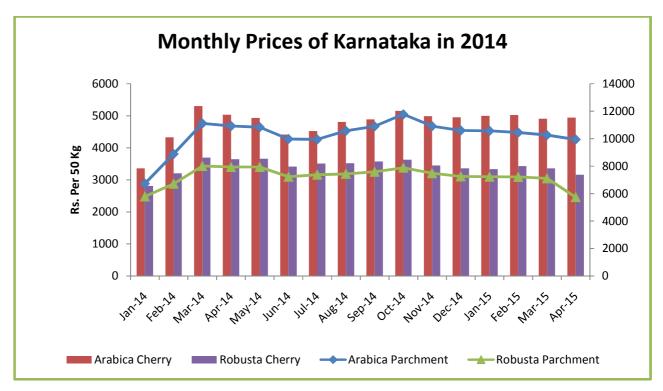


Coffee Prices of Auction Market & State-wise Market

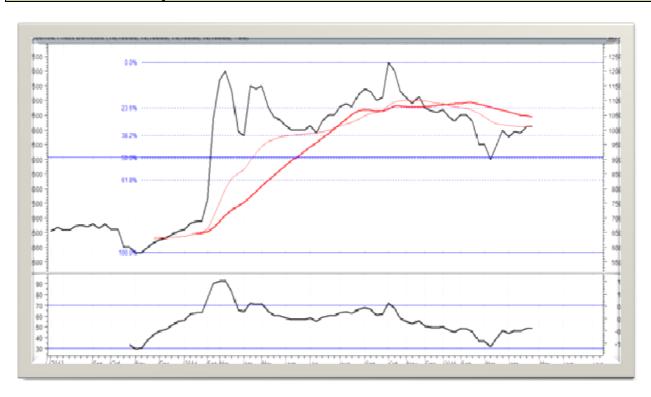

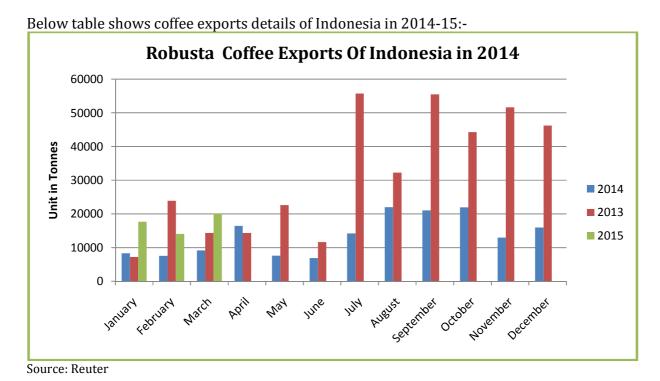
Weekly Futures Review -

ICE Arabica coffee future prices of May contract advanced by 1.76% to 141.15 USC cents per Ib from 138.70 USC cents per Ib due to buying supports in the market during this week. As per exchange Cot data, speculators increased their net long position by 2646 to 16427 contracts in Robusta coffee contracts.

Brazil:- Brazil's output may touch the level of 47.28 in 2015/16 slightly higher from 46.78 million bags in previous year with Arabica's production at 35.05 million bags and Robusta's production 15.2 million bags according to Terra Forte. Other sources like Coex Coffee Group, Brazil may harvest crops down at 45.08 million bags in 2015/16 against 47.5 million bags in 2015/16.

Indonesia: According to Indonesian Coffee Exporters and Industries Association, coffee exports of Indonesia in March-2015 stood higher by 73% to 20,246.26 tonnes against 14038.07 tonnes in previous month on good demand. Total 221242.6 tonnes of coffee is exported by Indonesia in 2014 lower from 355771.20 tonnes in 2013. Total coffee exports quantity may fall to 350,000 tonnes in 2015 against 382,774 tonnes of last year end.

As per sources, coffee output of Indonesia is expected to decline to between 650,000 and 700,000 tonnes in 2015 as compared to 711,513 tonnes in 2014 due to adverse weather condition.

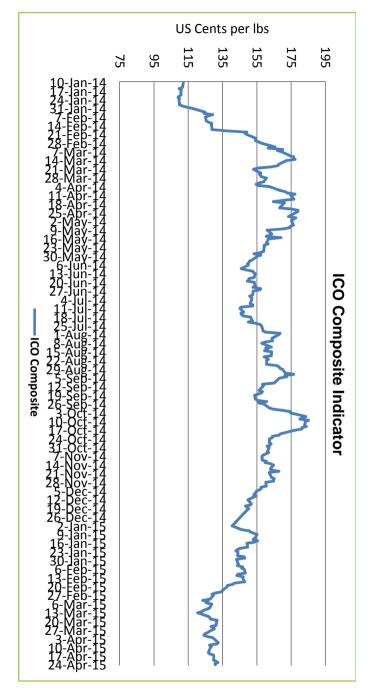

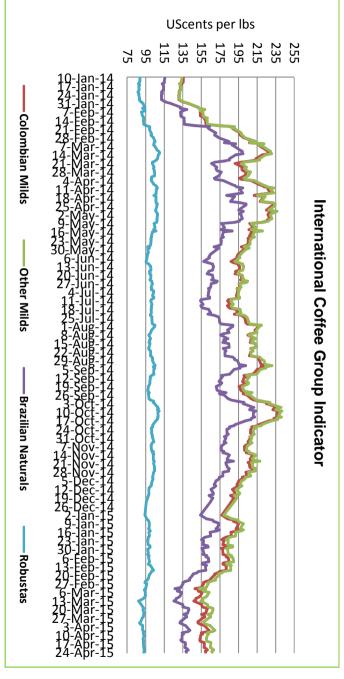
