

Executive Summary

Domestic Coffee Market Summary

Coffee prices declined in Karnataka physical market during week ended 2nd December 2016 on dull trading activities. New rule as applied by the government to ban on Rs. 500 and Rs. 1000 has influenced the market activities. Lower volume of rainfall of this season effected growth of coffee tress. Picking of Arabica coffee beans started in parts of Chikmagalur, while Robusta expected a bit early by first week of December since dry weather.

According to recent released data by the Coffee Board Of India, the post blossom estimates of total coffee crop size for the season 2016/17 is placed lower by 8.04% or (28,000 MT) to 320,000 MT against 348,000 MT in the current season 2015/16 due to poor rainfall and high temperature during growing period of time. While, Arabica coffee crop size for 2016-17 is placed down by 3.38% (3,500 MT) over the corresponding final estimate of 2015-16, while the Robusta estimate has shown a decrease of -10.02% (24,500 MT) over the corresponding final estimate of 2015-16. The hot and humid weather along with insufficient showers resulted in pinking and scorching of buds in Robusta.

As per the Coffee Board of India, provisional Indian green coffee exports to 1st January 2016 to 1st December 2016 is registered higher by 17.62% at 264249 metric tons compared to 224646 metric tons in the corresponding period of previous year. India re-exports maximum Instant type of coffee. Instant Coffee exports from 1st January 2016 to 1st December 2016 this year, recorded down by 12.50% at 23108 metric tons from preceding year volume of 26411 metric tons. Total provisional exports of Arabica parchment, Arabica Cherry and Robusta Cherry is placed higher by 24.04 at 37744, 16.68% to 11793 metric tonnes and 31.58% at 163999 metric tons respectively from 1st January to 1st December against exports volume of 30428 metric ton, 10107 metric tonnes and 124673 metric tons respectively in the corresponding period of last year. However, Robusta parchment is registered lower for 27327 metric tonnes with a decline of 16.53%.

Recommendation:

Weekly Call -: Market participants are advised to go short for short the period of time.

International Coffee Market Summary

According to Cecafe, Brazil shipped total coffee beans at 2999483 60 kg bags in November 2016 against 2974790 60 bags in October 2016. The country had exported total 3116107 60 kg bags of coffee beans in November 2015.

As per ICO report, Global coffee exports fell 1.9 percent in October from the same month last year to total 9.13 million 60kg bags. Robusta coffee exports in October, the first month of the 2016/17 season, were down 12.9 percent year on year at 3.02 million bags. Arabica coffee exports in October were 4.7 percent higher than in the same month last year, at 6.11 million bags.


As per government, Vietnam is likely to ship total 1.64 tonnes (27.33 million 60 kg bags) of coffee beans in December 2016 higher by 37.7% against last month record in the previous year. Little rain is likely to fall in most of Vietnam's coffee growing province in the next two weeks before the dry season begins which may impact current coffee. While in the view of traders, Coffee exports from Vietnam are likely to jump to 150,000 tonnes (2.5 million 60-kg bags) this month as the harvest nears its end up from 120,000 tonnes estimated for November.



Coffee Crop Situation In India:-


According to the Coffee Board of India, India is likely to produce coffee beans lower by 8.04% to 320000 metric tonnes in 2016/17 season against 348000 metric tonnes 2015/16 on account of delayed blossom and backing showers along with high temperatures especially in major coffee growing areas of Karnataka and to some extent in Kerala. Arabica coffee production estimates is placed 3.38% down at 100000 metric tonnes for 2016/17 from 103500 metric tonnes in last season while Robusta crop is placed at 220000 metric tonnes with a significant decrease of 10.02% compared to 244500 metric tonnes.







International Market Updates

ICE coffee future prices slipped by 8.30% to 141.80 cents/lb in this week, as on 1st of December 2016 against 154.65 cents/lb of the last week due to lackluster trading activities. ICE Arabica coffee futures fell on Friday as top producer Brazil's currency extended this week's sharp decline and funds further scaled back long positions.

Indonesia:- Indonesia shipped 22,284.4 tonnes of Robusta coffee beans from its main growing area in Sumatra in November, a 19 percent increase from a year earlier, and the first increase since November 2015. The world's third-largest Robusta producer shipped 18,684.6 tonnes of Robusta from Sumatra in the corresponding month last year. Coffee data is released monthly from the Lampung trade office in Sumatra.

Vietnam:- According to traders, The pace of coffee picking will accelerate in Vietnam supported by better weather condition and firmness in coffee prices. Central Highland, one of the coffee belts of Vietnam, started early harvest last month but the main cherry-picking period is expected to begin mid-November in the world's top Robusta producer. However, rainfall in the last week delayed the harvesting pace and affected quality of beans. As of now, there is no rainfall and it is sunny days. This may help coffee cherries ripen faster. Pace of picking may increase if sunlight continues for 10 days. Traders have stored high volume of old stocks, which may be exported in this month. As per sources, total production of the country may decline by 10 to 20% due to drought early this year.

Kenya:- The maximum price of Kenya's benchmark grade AA coffee slightly fell at this week's auction from the last sale two weeks ago. Kenya produces high-quality coffee sought by roasters from other countries to blend with their beans.





- However, 14 days EMI stood slight down at 152.54 against 159.80 in the market hints downward momentum in the market.
- Lower volume and prices indicates further short build up phase of the market.
- On the other hand, RSI is lower at 59.44 compared to 60.13 of last week record indicating week tone in the next week.

Strategy: Market participants are advised to stay away for the short period of time.
