

# **Domestic market summary**

#### **Domestic Market Scenario:**

Government of India has proposed merging the Jute Corporation of India (JCI) and Cotton Corporation of India (CCI) to form a large public sector entity to handle all textile fiber procurement. A request for proposal (RFP) has been issued in order to appoint a consultant for the merger of both PSUs under the Ministry of Textiles. Cotton traded with a steady tone across major spot markets of North India in January 2022. Indian cotton Shanker-6 prices remained steady near Rs. 73,300 to 75,500 per candy in January compared to previous month price of Rs. 66,011 per candy. Cotton prices at Rajkot traded at Rs. 10,158 per quintal last month.

**Monthly Price Outlook** : The Kapas prices likely to remain steady between Rs. 10,200-10,500/q in the Rajkot market and the prices of medium staple length in Adoni market are likely to hover around Rs. 8600-10,200/q in the coming month.

#### Major Market Highlights:

Cotton Association of India expects the area under the cotton crop to expand by 20-25 percent in the upcoming 2022-23 season across all the 10 major cotton producing states due to higher demand of cotton seed and the higher rates of raw cotton currently prevailing in the market. Cotton Association of India has also proposed a moderate increase of 3-5 percent in the cotton crop's Minimum Support Price (MSP) to protect cotton growers' interests.

According to the Union Budget 2022-23, out of the total allocations of Rs. 12,382 crore for the textile sector for next Financial Year, around Rs. 133.83 crore has been allocated for Textile Cluster Development Scheme and Rs. 100 crore for National Technical Textile Mission and Rs. 15 crore each for PM Mega Integrated Textile Region and Apparel Parks scheme and the Production Linked Incentives scheme.

Tamil Nadu government and the Southern India Mills Association have continued to urge the Central government to remove the import duty of 10 percent on cotton to ease the cotton and yarn prices in the domestic market and keep the power looms, and textile and apparel sectors viable

Cottonseed prices in Gujarat have increased in last week amid improved demand for raw cotton in the market mainly from spinning and ginning mills. Cottonseed prices are currently ranging between Rs. 8,800 to Rs. 10,500 per quintal.

As per AgriWatch estimate, cotton production in Gujarat is expected to be lower in 2021-22 season because of lower sown area around 22.53 lakh hectares as compared to 25.53 lakh hectares in the previous season.



**Production Estimate** - As per the Government's 1st Advance Estimate, cotton production for 2021-22 have been projected at 362.19 lakh bales, which is 2% higher than the previous year's final production estimate of 353.84 lakh bales.

As per AgriWatch estimate, 2021-22 production is lower at 350.60 lakh bales against the previous season estimate of 365 lakh bales. Production is expected to be lower in the 2021-22 season mainly because of lower sown area in 2021-22 season at 119.66 lakh hectares as compared to previous season of 128.07 lakh hectares and the arrival pattern supports this estimate largely.

Cotton Association of India has reduced its December estimate of the cotton crop for the 2021-22 season by 12 lakh bales to 348.12 lakh bales from its previous estimate of 360.13 lakh bales. The Association has attributed the reduction in crop estimate to the drop in production in states including Punjab, Haryana, Rajasthan, Gujarat, Telangana, Odisha and Karnataka.

The total cotton supply for the month of October 2021 to December 2021 remained at 218.52 lakh bales, which consisted of the arrivals of 140.52 lakh bales, imports of 3 lakh bales during the month of December 2021 and Opening Stock of 75 lakh bales equivalent to 79.69 lakh running bales at the beginning of the season on 1<sup>st</sup> October 2021. Further, the CAI has estimated cotton consumption for the months of October to December 2021 at 86.25 lakh bales while export shipment of cotton during the months of October to December 2021 is estimated at 18.50 lakh bales. Stock at the end of 31<sup>st</sup> December 2021 is estimated at 113.77 lakh bales. The mills have on an average 68 days cotton stock in their godowns.

Due to the good export parity in the 2020-21, exports are likely to increase to 75 lakh bales. Exports during the 2021-22 season is estimated at 50 lakh bales whereas, the imports in 2021-22 are likely to be around 12 lakh bales around 2 lakh bales higher from 2020-21 season.

The total cotton availability by the end of the season in 2020-21 is estimated at 478.82 lakh bales and an lower availability is expected in 2021-22 season of around 441.42 lakh bales.


Total domestic consumption in 2021-22 is expected to increase to 330.00 lakh bales.

So, the increase in consumption has resulted in lowering ending stocks of around 78.82 lakh bales in 2020-21 and is likely to occur this year too, the ending stocks by the end of 2021-22 season is estimated to be 61.42 lakh bales.


#### Kapas (Raw Cotton) Monthly Price Scenario

**Monthly Price Review:** Monthly kapas average price at Rajkot and other markets were significantly higher and stood at Rs.10,159/quintal in Rajkot and Rs. 9476/quintal in Hisar as compared to previous season at Rs. 9047/quintal in Rajkot and Rs. 8451/quintal in Hisar.






#### Kapas Monthly M-o-M Price Scenario

#### Spot Price versus MSP


Average kapas price at Gondal market stood slightly higher at Rs. 10,256/qt in January 2022 as compared to Rs. 9008/qt in December 2021.






#### Lint price Outlook

## **Cotton Fiber price Outlook**

The average spot price quoted for Shankar-6 (29mm) by CAI was Rs.73890 per candy (of 355.6 kg each) during January, higher than Rs.66011 per candy from previous month.While the prices during the same month last year were low around Rs. 43256 per candy. Agriwatch expects cotton fiber to remain around of Rs.70,000-70,200 per candy in the coming month amid increase in arrivals.








## Cotton Seed Oil Cake monthlyPrice Scenario

The average price of cottonseed oilcake in the Kadi market was Rs. 3330 per quintal from Rs. 2875 per quintal and in Akola was at Rs. 3343 per quintal from Rs. 2855 per quintal the previous month. The demand in the local market has improved in the January as compared to previous months.

## **International Market Scenario**

ICE front month futures was higher by around 11% in Jan'22 month compared in Dec'21. The average of ICE Dec contract stood high around 126.03 cents/lbs in Jan'22, up by 11 points compared to the average price that stood in Dec'21 around 113.23 cents/lbs.

#### Major Market Highlights:

Due to shortage of feeder vessels and a high unloading time, Bangladesh may face a crisis of cotton from March 2022 as the global shipping companies are unable to carry containers to Bangladesh. According to Bangladesh Textile Mills Association, the country also fears a suspension of production in spinning mills and rise in yarn prices in the local market if they failed to get cotton on time.

Cotton Prices in Brazilian local market may continue to firm up as most of the 2020-21 crop has already been traded. Brazil's National Supply Company (CONAB) estimates cotton production at 2.7 million tonne in the 2021-22 season, which is around 11 percent higher as compared to the previous season. The planted area may increase to 1.542


million hectares in the second cotton crop of 2021-22 season. Brazil cotton production is expected to increase because of regular rains early in the season.

According to USDA, World Agricultural Supply and Demand Estimate, January 2022 report, US is projected to produce around 17.62 million bales of cotton for the 2021-22 season, about 660,000 bales lower than the previous month bringing its ending stock estimate at 200,000 bales lower to 3.20 million bales. The USDA has also cut its global output estimate by about 610,000 bales to 120.96 million bales, bringing ending stocks forecast to 85.01 million bales from 85.73 million bales last month. However, USDA has trimmed US exports estimate by 500,000 bales to 15.0 million bales, citing lower US crop and continuing logistical issues.

#### Cotlook A Index

The average CotlookA Index stood higher at 132 US cents per lb in January month and that has increased by 10 percent from previous month.
