

# COTTON WEEKLY RESEARCH REPORT 10th October 2022

## **Domestic market summary**

## **Major Market Highlights:**

Cotton market remained steady during the week under review. North Indian Cotton arrival were affected due to rains. Cotton Shanker-6 prices remained between Rs. 69,000- Rs. 70,500 per candy. Rainfall was also reported from the Western belt of cotton crop but so far, no major crop loss has been reported. Cotton mills has reduced their production as yarn off take is low and yarn prices are under pressure.

#### **Domestic Market Scenario:**

As of Sept. 30<sup>th</sup>, 2022 Cotton sowing has reached 127.50 Lakh Ha. Vs 118.59 Lakh Ha. same period last year. Agriwatch expects overall the cotton sowing to reach 128 Lakh Ha. in 2022-23 season. Earlier, due to excess rainfall in July month cotton sowing was affected in central and southern India. As per AgriWatch the recent rains during the last week in Northern and Central India is likely to affect the cotton crop which is currently in the flowering state.

According to the Punjab State Agricultural Marketing Board, around 46,000 quintals of cotton has arrived in this season by 04<sup>th</sup> October 22 which is comparatively lower from 2.33 lakh quintals by 04<sup>th</sup> October 21. Cotton prices have also dropped from Rs.9,050 per quintal to Rs.8,400 against the minimum support price (MSP) for cotton at Rs.6,380 per quintal.

Textile mills across India are waiting for the prices to stabilize to revive production. Several textile mills that use cotton as raw material are operating at less than 50% capacity at present because cotton prices had gone up to Rs.1 lakh a candy during the previous season and now have come down to Rs. 70,000 per candy.



Cotton crop is expected to get affected due to heavy rains in Telangana. The incessant rains in Khammam and Bhadradri- Kothagudem districts are expected to adversely affect cotton production. The areas of Enkoor, Konigerla, Errpaleum, Kusumanchi and Kamepalli of Khammam districts have reported heavy rains during the last few days.

As of 03<sup>rd</sup> Oct 2022, Gujarat Cotton sowing has reached 25,48,968 hectares for the 2022-23 season which is slightly higher compared to the previous season's sowing of 22,53,933 hectares. As per AgriWatch, Overall cotton arrivals had increased in the state for the coming 2022-23 season where as, prices have come down to Rs. 8,750 per Quintal against the minimum support price of Rs. 6,025 per quintal. The rainfall during the last week has affected the quality of cotton in some parts of Gujarat. Overall, the moisture percentage has increased to 30-35% in the new cotton. The market is currently witnessing low demand as textile mills are closed for the 2021-22 season but will soon start operations for the 2022-23 season as the new cotton season has started from 01<sup>st</sup> October 2022.

According to the market sources, the Haryana Agriculture Department's preliminary survey report, cotton crop has been affected in the state on over 39,000 hectares due to heavy rainfall during September month. For the 2022-23 cotton season, around 6.50 lakh hectares of land was sown under cotton cultivation which was comparatively lower than the previous season's sowing of 6.88 lakh hectares. As per AgriWatch sources, around 15-20% loss is expected across the state.



## Kapas (Raw Cotton) Weekly Price Scenario


**Weekly Price Review:** Weekly BT Cotton average prices at Rajkot stood slightly lower at Rs. 8,670/Qtl compared to previous week's Rs. 9,058/Qtl. Cotton prices at Amravati traded at Rs. 8,000 per quintal whereas prices in Hisar were slightly lower at Rs. 8,900 per quintal during the past week. Arrivals had been affected due to heavy rains during the last week in north India.






#### **Spot Price Comparison**

Cotton shanker-6 at Gondal market traded lower at Rs. 9,105 per quintal against the minimum support price of Rs. 6,380 per quintal. Overall the new cotton quality has been affected due to heavy rains in the market, around 25-30 percent moisture has been reported in the crop during the last week.



## **Lint price Outlook**

The average price stood slightly lower at Rs. 7104/maund this week compared to Rs.7166/maund previous week in Abohar, in Bhatinda prices were at Rs.7110/maund, and slightly lower in Sirsa at Rs.7090/maund from Rs.7133/maund previous week.





#### **Cotton Fiber price Outlook**

The average cotton fiber (Shankar-6) prices of premium quality have slightly lower and is currently at Rs.70000/candy and is likely to remain weak in the coming weeks. Prices are falling mainly because of a production cut by the textile mills.








# Cotton Seed Oil Cake weekly price Scenario

According to the U.S. Crop progress report, as of 02<sup>nd</sup> Oct, 2022, U.S cotton Cotton Bolls opening stands at 77 percent which is higher than that of the previous season (67 percent). In the previous week cotton bolls opening was 69 percent. Overall 4 percent of the U.S Cotton Crop is in excellent condition, 27 percent in good to a fair condition which was 27 percent in the previous week.


U.S. cotton exports has fallen to \$28.362 million in July 2022 from \$1062.59 million in June 2022. Although, U.S. had exported large quantities till June 2022 due to the scarcity of cotton fibre along with higher prices in the international market. On a quarterly basis, cotton shipments from the U.S. rose to \$3.328 billion in the second quarter from \$2,820 billion in the first quarter. However, exports have fallen in the fourth quarter of last year to \$1.002 billion from \$1.254 billion in the third quarter of 2021. The U.S new cotton marketing season has begun from August 2022, however, the exports had reduced as compared to the previous 2021-22 season.

The raw cotton prices in Pakistan has decreased in the local market along with the decrease in international market. The rate of quality cotton has decreased by Rs.3,000 per maund. The rate of Putti was decreased by Rs. 800 to Rs, 1,000 per 40 kg. however, the cotton production has also been affected in Pakistan mainly due to heavy rainfalls.

#### Cotlook A Index

Cotlook A Index was lower this week. The Cotlook A Index was at 103.43 cents/lb lower as compared to the previous week (107.08 cents/lb).






# **Pakistan Spot Prices**


