## **Summary**

Agriwatch expects that maize would trade steady to range bound bias for coming near term, due to slow demand prices would not rise in near term. Whereas, in long run due to predicted late and reduced Rabi arrivals along with expectation of increase in demand as per seasonality trend prices would rise. Sources revealed that good quality maize is being traded in Bihar between Rs. 1,975 to Rs.2,050 per quintal. Also, poultry demand seems to have slowed down since past two weeks. Poultry feed maize is being supplied to Kolkata and Siliguri at Rs. 2,000 per quintal sourced from Bihar.

The cottonseed oilcake market showed an increasing trend last week. The average price of cottonseed oilcake in the Kadi market has increased around 2 percent and were at Rs. 2806 per quintal from Rs. 2778 per quintal previous week and in Akola market prices were at Rs. 2823 per quintal from Rs. 2783 per quintal the previous week. Although the cottonseed oil prices were higher at Rs. 1245 per 10kgs at Rajkot. Prices have also fallen in Hyderabad and Mumbai market by 2 percent and were at Rs. 1231 and Rs. 1237 per 10 kgs respectively.

During the week of December 16 to 23, 2021, the weekly average price in India was up by 1.49 percent at Rs. 2146.82 per quintal against Rs. 2115.34 per quintal the previous week. Also, wheat average prices increased by 14.51 percent from Rs. 1874.77 per quintal same time last year. On the 20th December the price of wheat in Kanpur market for mill delivery was Rs. 2020 per quintal which is 0.49% lower than Rs. 2030 per quintal the previous month. As most of the traders have purchased wheat stocks for coming 2-3 months, the demand is not upto the level because of the free ration scheme. As a result, the prices remain steady with not much movement in the prices. Also, cabinet ministry has announced extension of PMGKAY for another four months till March 2022. Earlier, the PMGKAY was extended till 30th November.


As of 17th December, wheat sowing was done in 277.709 lakh hectares down by 2.438 lakh hectares from 280.147 lakh hectares the previous year during corresponding period. In Madhya Pradesh, sowing was done in around 70.000 lakh hectares up by 5.030 lakh hectares from 64.970 lakh hectares the previous year as per ministry of agriculture. Markets regulator Sebi on Monday directed stock exchanges not to launch new derivative contracts in wheat, crude palm oil, moong and few other commodities till further orders .As per sources, 8.97 lakh tonnes of wheat were exported from India during the month of November 2021 at an average FOB of \$320.67 per tonne. Bangladesh continues to be the largest importer of Indian wheat with 4.45 lakh tonnes followed by Philippines with 1.56 lakh tonnes of wheat.FCI is proving the stocks to the traders, but since due to free ration scheme extended further for next four months, the demand has fallen as a result the sales have been lower. During the week ending 17th December, approximately 0.82 MT of wheat was sold by FCI which is down by 58.63 percent from 1.99 lakh tonnes during the week ending at 10th December.


Soymeal prices are likely to trade with range bound with weak amid weakness in soybean on subdued soymeal demand. The soy meal prices (Indore) are likely to feature range-bound movement between Rs. 50,000 – 55,000 /MT.





## Soy meal

This week RM seed prices remained under pressure and trading near five month low, quoted down by 2.1% on record acreage in the country, However global dynamics still underpinning the prices.Rapeseed Mustard weekly average price went down by 2.1% to Rs.8,079/Qtl, as compared to Rs 8,250/Qtl last week. The market made a low of 7,913 and high of 8,238 during the week. In Sri Ganganagar, the weekly average prices of rapeseed oilcake too went down by 3.06% to Rs 3,166/Qtl from previous week at Rs. 3,266/qtl.This week in Rajasthan, total mustard arrival stood at 5 lakh bags as compared to previous week at 4.8 lakh bags.

AW has revised India's 2021/22 rapeseed-mustard production up to 8.54 million tonnes from 8.0 million tonnes estimated in its previous forecast and it is up 18% from 7.21 million tonnes estimated last season.

As per Agriwatch estimates, this season all India RM seed acreage likely to remain above 84 lakh hectare and production at 97 to 100 lakh tonnes. According to GOI, as on 10th Dec, All India Mustard sowing is up by 23.8% at 81.65 Lakh Ha compared with 65.96 Lakh Ha last year.

According to Central Organization for Oil Industry and Trade (COOIT) production of the mustard to increase to a record 100-110 lakh tonnes this season. According to Department of agriculture, Rajasthan, as on 16th Dec, Rapeseed Mustard sowing is up by 33% and stood at 33.88 lakh hectare vs 24.43 lakh hectare last year same period. As per sources, overall crop condition seems good in Rajasthan.

Mustard sowing expected to end with 18-20% increase in acreage as farmers are opting mustard over other crops amid lucrative prices. As per Agriwatch estimates, till 30th Nov'21 76 lakh tonne crushing has been completed, 10.8 lakh tonne is with farmers, processors and stockists. There is no procurement by NAFED and HAFED. Ending stock is estimated at 3.2 lakh tonne.

Rajasthan govt. has imposed stock limit on oil seeds and edible oils on 26th Nov'21 till 31st march 22. Stock limit for Mustard seed, Toria, Taramira and Rayda for whole sellers is 2000 Qtl and retail trader oilseed storage limit pegged at 100 Qtl.







Sources revealed that maize in Nizamabad market is being traded at Rs. 1,850 per quintal. Loose maize in market of Davangere, Karnataka is being traded between Rs. 1,600 per quintal to Rs. 1,650 per quintal.

Corn on CBOT fell by 16.24 USD/MT to 215.44 USD/MT for December '21 contract as compared to previous week. Agriwatch expects that Corn on CBOT would be affected by higher prices of corn in international market on one hand and demand from the ethanol production industry on other hand.

U.S. Maize exports have reached to 116.44 MMT for the 2021-22 marketing year, with the exports of 10.93 MMT for the period of (3rd Nov – 9th Dec) 2021, exports were up by 21 percent from the previous week and up by 11 percent from prior 4-week average, to the destinations like Mexico (317,000 MT, including 28,300 MT - late), China (274,800 MT), Japan (192,700 MT), Canada (158,600 MT), and Colombia (131,400 MT).

In Lawrence Road the prices remain steady with slightly on down side by 0.09 percent. In Indore market, the prices remain firm and was up by 2.71 percent. Also, in Ahmedabad an Kota market, the prices were steady to slightly down by 0.69 and 0.78 percent.

Outlook: Feed prices are expected to feature in a range bound zone with mixed bias in coming week.
