- As seen in above chart market is currently in downtrend, moving in a channel, lower channel can be characterized as support and upper channel can be characterized as resistance.
- During the day, Guar seed extended previous day gains and went up by 1% on long buildup and closed at 5,237, during the day Guar seed made low of 5,150 and a high of 5,258.
- Currently trading below 18, 50 and 100 DMA indicating weak sentiments.
- MACD and DIF indicating weak momentum.
- RSI has slightly rebounded and still is in oversold zone, indicating weak buying strength.
