Executive Summary

During the month under review, monthly average prices of Guar seed went down by 4.4% to Rs. 5,572/qtl. as compared to previous month at Rs. 5,830/qtl. amid the falling guar seed arrivals and weak demand in the market. guar gum monthly average prices also went down by 4.4% to Rs. 11,958/qtl as compared to previous month at Rs. 12,504/qtl in tandem with Guar seed prices.

As per data released by Baker Hughes, the average number of oilrigs in USA went down by 13 to 591 in Mar '23 as compared to 604 in the previous month


Outlook – Guar seed (Spot, Jodhpur basis):

Guar seed delivery prices are expected to show weak bias amid weak demand and less arrivals. The seed prices are likely to trade in the range between 5,500 –6,700/Qtl. in the short-run and guar gum likely to trade in the range of 11,000-12,800.



Domestic Market Fundamentals

During the month under review, monthly average prices of Guar seed went down by 4.4% to Rs. 5,572/qtl. as compared to previous month at Rs. 5,830/qtl. amid the falling guar seed arrivals and weak demand in the market.



During the month under review, guar gum monthly average prices also went down by 4.4% to Rs. 11,958/qtl as compared to previous month at Rs. 12,504/qtl in tandem with Guar seed prices.






Oilrig count Vs Guar gum price

As per data released by Baker Hughes, the average number of oilrigs in USA went down by 13 to 591 in Mar '23 as compared to 604 in the previous month. While the average Guar gum prices also went down by 4.4% this month as compared to the previous month.

The oil rig count has continuously fallen for the 2nd month in a row, indicating the declining oil demand from the US, which is clearly reflected in the guar gum prices that has also extended the previous months' loss.



WTI Crude Oil

Crude oil prices experienced a 2.7% month-over-month decrease. This can be attributed to the perception that the market is well-stocked with oil, even as concerns over the global



economy's future outlook and a stronger US dollar have not abated. Compared to the same period last year, prices dropped significantly by 14.2%. This week, an increase of 8% was seen in crude oil prices, due to which the guar gum prices also showed an improvement and went up by 2.12%.



Arrivals


In the period between Oct-Mar '23, Guar seed arrivals declined by 28% at 1,40,949 tonnes as compared to 1,95,382 tonnes five years average. In the month of Mar '23, the arrivals went down by 58% to 7,286 tonnes as compared to 17,167 tonnes five-year average.

Guar Seed Price Seasonality

The guar seed prices in the month of Mar'23 went up by 23% as compared to five-year average price while compared to the previous month, it decreased by 4.4%.






Guar Gum Price seasonality

The guar gum prices in the month of Mar '23 went up by 36% as compared to five-year average price while compared to the previous month, it declined by 4.4%.




Guar Gum Export seasonality






Cumulative Guar Gum Exports






Guar Split export seasonality



Cumulative Guar Gum Exports







Export Scenario

Guar Split Exports

India's guar split exports increased in the month of Feb '2023 by 19% to 4,420 tonnes compared to 3,711 tonnes previous month at an average FoB of US \$1,843 per tonne in the month of Feb '23 compared to US \$1,936 per tonne previous month. However, the guar split shipments declined by 19% in Feb '23 compared to the same period last year. Of the total exported quantity, around 4,100 tonnes bought by China, US 260 tonnes and Switzerland 60 tonnes.









Guar Gum Exports:


India's guar gum exports decreased in the month of February 2023 by 13% to 18,488 tonnes compared to 21,326 tonnes during previous month at an average FoB of US \$1,558 per tonne in the month of Feb '2023 as compared to US \$1,482 per tonne previous month. Further, the gum shipments were marginally down by 0.1% in Feb '2023 as compared to the corresponding year. Out of the total exported quantity, around 5,448 tonnes bought by USA, Russia 3,726 tonnes, Germany 2,552 tonnes, Canada 936 tonnes, China 740 tonnes and Australia 479 tonnes.








Total Cumulative Guar exports: Oct-Feb '23 recorded 1% higher exports at 1.27 Lakh tonnes as compared to 1.25 Lakh tonnes previous year same period.



Millers/Processors Margin

As seen in the chart, the average net crush margin of guar seed increased in March '23 to 88/ Qtl as compared to -20/ Qtl in February '23, due to declining guar seed prices.

Technical Commentary:

- As seen in the above chart, market is currently trading above 9,50 and 100 DMA, while it is below 18 DMA, indicating weak market sentiments.
- During the month under review, Guar seed prices were bearish and went marginally down by 0.99%, market made low at 5,382, high at 5,778 and closed at 5,703.
- MACD oscillator momentum indicating bearish sentiments.
- RSI is near 50, indicating weak buying strength.

- During the month under review, Guar gum prices went down by 3.93%. Market made low at 11,200, high at 12,233 and closed at 11,746.
- MACD is indicating bearish sentiments.
- RSI is near 57, indicating weak buying strength.
