Executive Summary

Domestic Guar Seed Market Summary

All India weekly average prices increased by 0.67 percent to Rs. 3400.08 per quintal during the week ended 08th June 2018. Guar seed average price were ruling at Rs 3377.41 per quintal during 24-31 May 2018. As compared to prices in the week 01-08 June 2017, the prices are firm by 3.66 percent. Prices are expected to remain steady to weak in coming days.

Guar seed future July contract continued its downtrend and closed at Rs 3656.50 per quintal. As of now, fundamentals are not in support of guar seed although small technical recoveries can be expected. Normal monsoon forecast is also weighing on prices. If current situation continues, Guar is likely to touch Rs 3200-3250 per quintal in future. Traders are advised to sell guar seed.

As per millers recovery of guar gum from guar seed is coming around 29.0-31.0 kg of guar gum this year compared to around 31-32 kg last year. Export demand for guar gum is normal. As of now guar gum prices in Jodhpur are hovering around Rs 7600 per quintal.

As per forecast by IMD, monsoon is likely to be 97 percent of the long-term average. As of now a trough is extending from Northwest Rajasthan to Bihar. Therefore, it is highly likely that Rajasthan and Haryana, the main growing states for guar seed, will witness thundershowers. Sowing of guar is likely to be slightly lower as compared to previous year due to lower returns compared to other competitive crops.

As per data released by Baker Hughes the number of oil rigs in USA has increased to 1062 as on 08th June 2018 up by 2 compared to last week and by 135 compared to 09th June 2017. The total number of oilrigs was recorded at 2179 worldwide in May'18 compared to 2096 in the same month last year. Although the number of oil rigs is rising but alternatives to guar gum are slightly affecting exports from India.

As per trade sources, export of guar split has declined in the month of April. Exports in the month of April are down by around 30.59% compared to previous month. India exported around 2943 tonnes of guar split in the month of April at an average FoB of \$1538.89 per tonne. Of the total quantity around 1482 tonnes and 1100 tonnes has been exported to China and Unites States respectively.

As far as Arrivals are concerned, Adampur (Haryana) market (biggest market of guar in North) reported lower arrivals (4200 quintals) compared to previous week arrivals of 6900 quintals.

As far as Arrivals are concerned, Bikaner market reported lower arrivals (450 quintals) compared to 800 quintals in the previous week.

Weekly Call - : Market participants are advised to sell Guar seed at 3690 levels for a target of 3495 with a stop loss at 3759 on closing basis.





Guar Seed Fundamental Analysis and Outlook-:

Domestic Front

- In the week ended 08th June'18, Guar seed weekly average prices decreased by Rs 122.50/-qtl during the week compared to previous week and settled at Rs 3789 per quintal.
- In addition, Guar gum weekly price decreased by Rs 366.67 per quintal and settled at Rs. 7583 per quintal. Weak demand for guar gum from domestic as well as overseas market keep prices at lower side in previous week.
- According to first advance estimate for 2017-18, issued by Gujarat's Department Agriculture for Guar seed, the area, production and yield are 200000 hectares, 144000 tonnes and 721 kg/hectare respectively. As per third advance estimate for 2016-17 issued by Gujarat's Department of Agriculture for Guar seed the area, production and yield are 352000 hectares, 242000 tonnes and 687 kg/hectare.
- According to first advance estimate for 2017-18 issued by Rajasthan's Department of Agriculture for Guar seed, the area is 3167018 hectares. As compared to third advance estimate for 2016-17, the area, has decreased by 362989 hectares.







Millers/Processors Margin

In the week ended 08th June'18, average crush margin is Rs. -33.62/Quintal, compared to last week's -31.35/Quintal. Therefore, crushing is not favorable for Millers/Processors.


Higher degree of increase in guar seed prices compared to guar gum prices, led the margin down this week.


Guar Seed to Gum Ratio


