Executive Summary

Domestic Guar Seed Market Summary

All India weekly average prices increased by 5.71 percent to Rs. 4213.70 per quintal during the week ended 30th October 2018. Guar seed average price were ruling at Rs 3986.05 per quintal during 16-23 October 2018. As compared to prices in the week 24-30 October 2017, the prices are firm by 28.79 percent. Prices are expected to remain steady to weak in coming days.

Guar seed future November contract touched a low of Rs 4495.00 per quintal before closing at Rs 4645.50 per quintal in last week. As per trade sources, guar is likely to be bearish with small technical recoveries in coming weeks and touch Rs 4400-4450.00 per quintal.

Guar prices recovered sharply on 02nd November'18 after remaining weak for the whole week due to buying from millers. Millers bought in bulk to cover their requirement of running their mills for upcoming months. This is one of the main reasons for spot market prices being higher compared to futures during past days in last week.

As per data released by Baker Hughes the number of oil rigs in USA has decreased to 1067 as on 02 November 2018 down by 1 compared to 26th October 2018 and up by 169 compared to 03rd November 2017. The total number of oilrigs was recorded at 2258 worldwide in September'18 compared to 2081 in the same month last year. Slick water is expensive compared to guar gum. However, U.S. is still importing slick water due to fear of unexpected surge in price of guar gum. Therefore, exports are being slightly affected.

As far as Arrivals are concerned, Bikaner market reported lower arrivals (11200 quintals) compared to previous week arrivals of 15500 quintals.

As far as Arrivals are concerned, Adampur (Haryana) market (biggest market of guar in North) reported lower arrivals (5200 quintals) compared to previous week arrivals of 8900 quintals.

Previous Updates

As per trade sources, export of guar gum has decreased in the month of September by 24.72 percent compared to previous month. India exported around 18406 tonnes of guar gum in the month of September at an average FoB of \$ 1765.31 per tonne. Exports are expected to remain low in October-18 as well.

As per trade sources, export of guar split has decreased in the month of September. India exported around 4299 tonnes of guar split in the month of September at an average FoB of \$ 1446.82 per tonne.

Weekly Call - : Market participants are advised to sell Guar seed at 4750 levels for a target of 4600 with a stop loss at 4840 on closing basis.





Guar Seed Fundamental Analysis and Outlook-:

Domestic Front

- In the week ended 02nd November'18, Guar seed weekly average prices decreased by Rs 21.00/- qtl and settled at Rs 4852 per quintal.
- In addition, Guar gum weekly price decreased by Rs 16.67 per quintal and settled at Rs. 10117 per quintal. Weak demand for guar gum from domestic as well as overseas market kept prices at lower side in previous week.
- According fourth to advance estimate for 2017-18, issued by Gujarat's Department of Agriculture for Guar seed, the area, production and yield are 205000 hectares, 140000 tonnes and 682 kg/hectare respectively. As per final estimate for 2016-17 issued bγ Gujarat's Department of Agriculture for Guar seed the area, production and yield are 223000 hectares, 167000 tonnes and 749 kg/hectare.
- According to fourth advance estimate for 2017-18, issued by Rajasthan's Department of Agriculture for Guar seed, the area, production and yield are 3432293 hectares, 1244830 tonnes and 363 kg/hectare respectively. As per final estimate for 2016-17 issued by Rajasthan's Department of Agriculture for Guar seed the area, production and yield are 3530007 hectares, 1404819 tonnes and 398 kg/hectare.







Millers/Processors Margin

In the week ended 02nd November'18, average crush margin is Rs. 181.29/Quintal, compared to last week's -225.49/Quintal. Therefore, crushing is not favorable for Millers/Processors.

Higher degree of increase in guar gum prices compared to guar seed prices led the margin up this week.

Guar Seed to Gum Ratio


Ratio of guar seed to guar gum for week ended 02nd November'18 is 2.09, higher compared to last week's 2.08


Overall, buoyant demand of gum from overseas and good demand of seed from millers has increased the overall ratio.
