#### **Executive Summary**

## **Domestic Guar Seed Market Summary**

- During the week under review, Guar seed Jodhpur delivery weekly average prices declined by 5.5% to INR 6,160/qtl as compared to previous week at INR 6,517/qtl. after two weeks of consecutive gain, in tandem with decline in crude oil prices by 2.73%. Even though there were lesser arrivals in the market, the prices have gone down due to weak demand. While the weekly average prices of guar gum slugged by 5.2% at INR 13,240/qtl. vs previous week at INR 13,967/qtl. in tandem with guar seed prices.
- Guar seed arrivals went down by 24% to 38,648 qtl. during the week under review as compared to 50,779 qtl. in the previous week.
- Month till date, Guar seed Jodhpur delivery prices went up by 29% at Rs. 6,038/qtl. as compared to October month closing at Rs. 4,673/qtl. While, the Guar gum prices went up by 27% at Rs. 11,700/qtl. as compared to October month closing at Rs. 9,200/qtl.
- As on 27th Jan '2023, as per data released by Baker Hughes, the number of oilrigs in USA decreased by 4 to 609 as compared to the previous week at 613.


#### Outlook – Guar seed (Spot, Jodhpur basis):

• Guar seed - prices are expected to trade with weak sentiments due to weak demand in the market. The Jodhpur Guar seed delivery prices are likely to trade in the range between INR 5,600–6,200/Qtl. in the short-run. Guar gum is expected to trade in the range of 12,000-13,800/qtl in near term.




#### **Domestic Market Fundamentals**

During the week under review, Guar seed Jodhpur delivery weekly average prices declined by 5.5% to INR 6,160/qtl as compared to previous week at INR 6,517/qtl. after two weeks of consecutive gain in tandem with decline in crude oil prices by 2.73%. Even though there were lesser arrivals in the market, the prices have gone down due to weak demand.








**Guar seed arrivals**: Overall Guar seed arrivals went down by 24% to 38,648 qtl. during the week under review as compared to 50,779 qtl. in the previous week. In Rajasthan, the arrivals went down by 30%, while in Haryana it went down by 4% as compared to previous week. The arrivals went down during the week due to weak demand in the market.



**Oil Rig count Vs Guar gum price**: As on 27<sup>th</sup> Jan '2023, as per data released by Baker Hughes, the number of oilrigs in USA decreased by 4 to 609 as compared to the previous week at 613, while the guargum weekly prices went down by 9% at INR 12,500 as compared to 13,800 in the previous week.





**Guar Split Exports:** India's Guar split exports increased in the month of December '2022 by 21% to 5,440 MT as compared to 4,500 MT previous month. While, the Guar split shipments went up by 66% in December '22 compared to the same period last year. Out of the total exports, around 3,400 MT (62.5%) was


bought by China, 1520 MT (28%) bought by the USA, 220 MT (4.04%) by Germany, 120 MT by Netherlands as well as Switzerland each and 60 MT by Canada.

Guar Gum Exports India's Guar gum exports increased in the month of December '2022 by 16% to 23,136 MT compared to 20,018 MT in the previous month. However, the gum shipments went down by 8% December 2022 as compared to the same period last year. Out of the total exported quantity, around 10,734 MT (46.4%) was bought by the US, 2,412 MT (10.42%) by

Russia, 2,365 MT (10.22%) by Germany, 658 MT (2.84%) by China and 561 MT (2.42%) by UK. We expect Guar gum export in Jan '22 to be around 22,000-25,000 tonnes.


**Total Cumulative Guar exports:** Oct-Dec '22 went up by 7% to 0.79 Lakh tonnes as compared to 0.74 Lakh tonnes previous year same period.





## Millers/Processors Margin

During the week under review, weekly average net crush margin of Guar seed went up at INR. -83.8/qtl. as compared to INR. -218/qtl. previous week as the demand for churi korma improved in the market amid the decline in guar seed prices and good export demand.
