Executive Summary:

- In Ahmadabad region of Gujarat, poultry feed makers quoted maize steady at Rs. 1400 per quintal. Starch feed makers quoted maize down at Rs. 1420 per quintal on Wednesday.
- Loading of Maize for Bangalore, Nammakal, Chitradurga, Sangli and Chennai at Rs. 1420 per quintal, Rs. 1420 per quintal, Rs. 1380 per quintal, Rs. 1420 per quintal and Rs. 1420 per quintal respectively, sourced from Davangere continued on Wednesday. As per trade sources, around 8-10% arrivals is damaged and fungus affected.
- In Delhi, hybrid maize was quoted steady at Rs. 1550 per quintal. Sources revealed that maize could trade steady in the near term. Maize stock could be around 2500 quintal in local market.
- As per IBIS data, exports of corn were reported around 0.019 million tons for the period of 16th Mar to 22nd Mar'15 mainly to Vietnam and Malaysia.
- As per 2nd advance estimate released by ministry of agriculture, maize production is estimated at 22.97 million tons for 2014/15. However, Agriwatch expect maize production in India at 21.01 million tons for 2014-15.

International Market Commentary:

Corn quote was decreased by \$ 7.18 / MT to \$ 148.09 /MT for May contract on CBOT market yesterday after USDA published corn planting intention and stock report. USDA forecasted corn planting at 89.199 million acres, down by 1.398 million acres from last year but higher by expectation of 88.731 million acres. Corn stocks as of March 1 were pegged at 7.745 billion bushels, higher by market expectation and last year stock of 7.008 billion bushels.

Outlook and Recommendation:

Market is likely to trade steady to weak in the near term.
