

Domestic Fundamentals:


- Menthol prices declined today in key markets due to higher arrivals and weak demand.
- Chinese economy slowdown and falling crude oil prices became the main influencing factor for weak demand of menthol. It is notable that China is the major importer of menthol from India.
- India has exported 2197 tons of menthol (Pepermint, spearmint, crystal, cornmint) in the month of December.
- Today 321 drums are arrived in the all India markets of mentha which are 4 drum higher arrivals compared to prior day.
- All flakes millers are running their plants at present due to good parity.
- Daily around 160 drums are consuming at all India level as reported.

Domestic Market Outlook: Menthol prices likely to move in a range with weak tone in the coming couple of trading session.
