

Soy Meal Fundamentals:

Soy meal, export prices, FOR Kandla, witnessed losses and quoted at Rs. 38,000/MT compared to Rs. 39,000/MT on Thursday.

India's oilmeal shipments almost halved in May from the corresponding period to 153,761 tonnes due to a plunge in soy meal shipments. India's soy meal exports plunged to 8,226 tonnes in May from 96,492 tonnes during the same period last year. India's oilmeal shipments fell 9.8 percent from a year earlier to 4.3 million tonnes in the 2013/14 fiscal year that ended in March.
