



Soy Meal Fundamentals: Soy meal (Indore) prices fell and was quoted at Rs 23,700/MT compared to Rs 24,000/MT on Thursday.

The Solvent Extractors' Association of India has compiled the export data for export of oilmeals for the month of May 2017.

The export during May 2017 is reported at 97,871 tons compared to 57,954 tons in May 2017 i.e. up by 69%. The overall export of oilmeals during April - May 2017 provisionally reported at 301,569 tons compared to 171,932 tons during the same period of last year i.e. Up by 75%.
