

CBOT Soymeal gave up all the gains in the yesterday's early session to close in red. Today the market is trading sideways in the early trade. Domestic physical market remained unchanged today.

The week ending 19<sup>th</sup> July weekly sales reported at 215.368 thousand tons against 341 thd tons last week. The cumulative exports has been accumulated at 9.83 million tons with another two months to go close the marketing year. USDA has estimated 2017-18 soymeal exports sales at 12.24 million tons nearly 1.7 million tons high against last year exports.

Old crop net sales has been reported at 166.39 thd tons against 131 thd tons last week whereas New crop net sales is down at 37.62 thd tons against 90.97 thd tons last week.
