- Indore soymeal inched to the lowest value of the year as it closed below 27000 last year. Bearishness in International meal market is continuously pressurizing Indian meal as Indian meal attempts to discover price parity.
- Meanwhile Indian officials inspected soy bean crusher's plant ahead of Chinses industrialist visiting Indian soybean plants.
 Indian govt are trying hard to push for soymeal exports in China as the country has appetite to consume all of India's surpluses.
