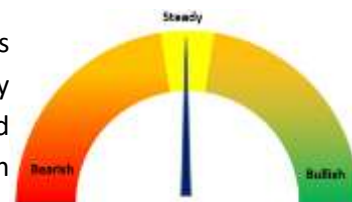


Soy Meal Fundamentals:

Today's Update- Soymeal Indore prices declined by 1.2% at INR 41,000/MT as compared to previous day. Year-to-date Soymeal prices are marginally down by 3.5%. Soymeal prices in the domestic market are expected to trade range bound with weak bias in the range of 40,000-43,000 in near term tracking, increase in spread between Ex-kandla and Ex-Rotterdam prices.
