

Oilseed Daily Fundamental Report 11th December, 2017

Oilseeds Domestic Fundamentals: Soybean (plant delivery, Indore) and rapeseed-mustard (Condition, Jaipur) noticed weak tone amid lack of buying interest in the cash market. Rabi oilseeds sowing progress is lagging behind last year. All India soybean arrivals in the major mandis declined to 173,400 bags compared to 341,500 bags on previous day. Further, the all India arrivals of the rapeseed-mustard declined to 130,000 bags compared to 170,000 bags on previous day.

The area coverage under mustard, as on 8th December 2017, is reported down 7.55% at 59.36 lakh hectares compared to 64.21 lakh hectares at the same period last year. The area under groundnut is reported higher by 2.33% at 3.21 lakh hectares and that of sunflower is reported higher by 3.24% at 1.21 lakh hectares.

The total sown area under rabi oilseeds, as on 8th December 2017, is lower compared to the previous year's level which is down by 7.55% at 67.79 lakh hectares compared to 72.16 lakh hectares during the corresponding period last year.

International Oilseeds Fundamentals: According to the General Administration of Customs, China imported 8.68 MMT of soybeans in November 2017, an increase of 48 per cent compared to previous month. Imports were 11 per cent higher compared to the same period previous year. Imports were higher in November as a backlog of shipments from United States arrived at the ports.

Outlook: Soybean (plant delivery) prices are likely feature range –bound to firm tone in near-term. The Indore (Plant Delivery) prices are expected to be in the range of 2900 – 3100 levels in the near-term.
