

# Oilseed Daily Fundamental Report 11<sup>th</sup> January, 2018

Oilseeds Domestic Fundamentals: Soybean (plant delivery, Indore) noticed steady tone amid normal demand in the market and rapeseed-mustard (Condition, Jaipur) witnessed easy tone amid overall weakness in edible oils in the domestic market. Soybean at CBOT closed lower amid expectation of record crop forecast due to be released by the USDA on Friday. All India soybean arrivals in the major mandis increased to 299,900 bags compared to 274,350 bags on previous day. Further, the all India arrivals of the rapeseed-mustard remained steady at 150,000 bags compared to previous day.

On a financial year basis, India's export of oil meals during April 2017 to December 2017 stands at 2,090,468 metric tonnes as compared to 1,169,914 metric tonnes in the same period of previous year showing an increase of 79% according to data released by the Solvent Extractor's Association of India.

International Oilseeds Fundamentals: The drought affecting Argentina's soy belt is expected to worsen this week according to meteorologist and farmers. This is likely to delay planting and raise concerns of frost affecting the crop in May. In Argentina, soybean is sown during mid October – first week of January. Delay in planting increases the chances of early frost affecting the crop in May.

According to consultancy Celeres, soybean crop in 2017/18 is expected to increase by 1.9 per cent to 111.8 MMT compared to previous estimates.

**Outlook:** Soybean (plant delivery) prices are likely feature range –bound to firm tone in near-term. The Indore (Plant Delivery) prices are expected to be in the range of 3150 – 3350 levels in the near-term.
