

Oilseed Daily Fundamental Report 2nd April, 2018

Oilseeds Domestic Fundamentals: Soybean (plant delivery, Indore) witnessed steady tone amid lack –luster trading activities and rapeseed-mustard (Condition, Jaipur) noticed firm tone on lower arrivals in the mandis. Most of the mandis remained closed financial year ending. At CBOT, market remained closed following 'Good Friday'. In Brazil till date around 71 per cent of soybean harvest is complete. Further, the all India arrivals of the rapeseed-mustard declined to 100,000 bags compared to 125,000 bags on previous day.

International Oilseeds Fundamentals: According to the planting intention report released by the USDA, soybean planted area for 2018 is estimated at 89.0 million acres, lower 1 per cent compared to previous year. It is below average trade estimates of 91.056 million acres.

In the latest USDA quarterly stock report, it has been reported that the US soybeans stored in all positions on March 1, 2018 totaled 2.11 billion bushels, up 21 percent from March 1, 2017. It is higher than average trade estimate of 2.030 billion bushels.

On -farm stocks are estimated at 855 million bushels, up 28 percent from a year ago. Off-farm stocks, at 1.25 billion bushels, are up 17 percent from last March. Indicated disappearance for the December 2017 - February 2018 quarter totalled 1.05 billion bushels, down 9 percent from the same period a year earlier.

Outlook: Soybean (plant delivery) prices are likely feature range –bound to firm tone in near-term. The Indore (Plant Delivery) prices are expected to be in the range of 3600 – 3900 levels in the near-term.
