

Oilseed Daily Fundamental Report 4th April, 2018

Oilseeds Domestic Fundamentals: Soybean (plant delivery, Indore) noticed steady tone amid lack –luster demand around higher levels and rapeseed-mustard (Condition, Jaipur) witnessed easy tone on increasing new crop arrivals in the mandis and weak tone of palm oil at BMD. Soybean at CBOT closed lower amid ongoing trade rift between U.S. and China. Till date China has not include soybean in the latest list of tariffs for agricultural commodities. However it might include soybean depending on the situation in the coming days. Further, the all India arrivals of the rapeseed-mustard increased to 500,000 bags compared to 250,000 bags on previous day.

International Oilseeds Fundamentals: According to data released by the Trade Ministry, Brazil's exports of soybean increased to 8.81 MMT in March 2018 compared to 2.86 MMT previous month. It exported 8.98 MMT soybean in March 2017. Soy meal exports stood at 1.32 MMT in March 2018 compared to 1.35 MMT previous month.

According to consultancy, AgRural soybean harvest in Brazil has reached 71 per cent till date compared to 74 per cent during the same time previous year and above a five –year average of 69 per cent.

According to the planting intention report released by the USDA, soybean planted area for 2018 is estimated at 89.0 million acres, lower 1 per cent compared to previous year. It is below average trade estimates of 91.056 million acres.

Outlook: Soybean (plant delivery) prices are likely feature range –bound to weak tone in near-term. The Indore (Plant Delivery) prices are expected to be in the range of 3600 – 4000 levels in the near-term.
