

Oilseed Daily Fundamental Report 17th April, 2018

Oilseeds Domestic Fundamentals: Soybean (plant delivery, Indore) and rapeseed-mustard (Condition, Jaipur) noticed weak tone amid forecast of normal monsoon this season and weakness in palm oil at BMD. The IMD released its first forecast of monsoon 2018. Some of the mandis remained closed today following 'Amavasya'. All India soybean arrivals in the major mandis declined to 31,250 bags compared to 42,050 bags on previous day. All India arrivals of the rapeseed-mustard increased to 455,000 bags compared to 365,000 bags on previous day.

According to the Indian Meteorological Department (IMD), in 2018 monsoon is expected to be 97% of the long –term average. There is very less probability of a deficient monsoon this season. The next assessment on monsoon will be done in June.

During kharif 2018, farmers are expected to produce more soybean than previous year following lower input cost, less effort and good prices of soybean prevailing in the market. There will be likely shift of acreage from cotton and pulses towards soybean, thereby resulting in higher soybean production this season.

International Oilseeds Fundamentals: The National Oilseeds Processors Association will release the monthly soybean crush data for the month of March on Monday. According to average estimates by analysts, soybean crush is likely to be around 168.247 million bushels higher than 153.060 million bushels crushed during the same period previous year.

Outlook: Soybean (plant delivery) prices are likely feature range –bound to weak tone in near-term. The Indore (Plant Delivery) prices are expected to be in the range of 3600 – 3900 levels in the near-term.
