

Oilseed Daily Fundamental Report 25th April, 2018

Oilseeds Domestic Fundamentals: Soybean (plant delivery, Indore) witnessed positive tone amid lower availability in the domestic market and rapeseed-mustard (Condition, Jaipur) noticed weak tone amid overall weakness in edible oils in the domestic market. Soybean at CBOT continued easy tone amid fears of likely decline in demand from China. China is the largest importer of soybean and according to market sources, no new deal has been signed with China since 11th April, 2018 following ongoing trade rift between U.S. and China. All India soybean arrivals in the major mandis increased to 101,550 bags compared to 100,800 bags on previous day. All India arrivals of the rapeseed-mustard declined to 370,000 bags compared to 400,000 bags on previous day.

The Haryana State Co-operative Supply and Marketing Federation has purchased till date around 1.20 lakh metric tonnes mustard during the current season. Around 62,966 farmers have so far benefitted with this purchase.

International Oilseeds Fundamentals: In the weekly USDA crop progress report released on 23 April; Soybeans planting are reported at 2% which is down from 5% from the corresponding period last year and same as the 5 year average of 2%.

According to a report released by the Ministry of Agriculture and Rural Affairs, China soybean output in 2018 is expected to increase by 1.9 per cent to 15.18 MMT compared to previous year. Soybean acreage is expected to rise 1.1 percent to 8.2813 million hectares. Farmers are likely to follow government's direction of increasing area under oilseeds.

Outlook: Soybean (plant delivery) prices are likely feature range –bound to firm tone in near-term. The Indore (Plant Delivery) prices are expected to be in the range of 3600 – 3900 levels in the near-term.
