

Pulses Domestic Fundamentals:

- **Moong & Urad cash markets are likely to trade range bound despite ongoing procurement activities in Maharashtra & south Indian states.** New arrival from Rabi crop and Markfed selling intention of old crop may put cap on upward momentum. Burma offers Moong at \$745 per tonne against \$780 per tonne in India. Weak tone is expected in the short term. Burma offers Urad FAQ at \$460 & SQ at \$590 per tonne basis Indian port.
- **Buying interest at current level for Tur continues amid govt.'s procurement on MSP.** As crop size is lower, buying interest might continue in coming weeks. It would not allow market to decrease from current level. It is trading in the range of Rs 4100-4500 in Gulberga. Burma offers new lemon Tur at \$375 per tonne basis Indian ports.
- **Markfed has issued selling tender for Urad & Moong in MP.** The quantity in question is said to be around 1.93 lakh qtl. for Moong & 5647 qtl. for Urad. It is from last season crop. Govt.'s agencies could not sell enough stock before this new tender. Private trades are not much interested
- **Chana market has improved slightly from Rs 3900 to Rs 4000 in Delhi market.** It may move up Rs 100 further from current level. However, higher crop size, likely new arrivals from MP & Maharashtra might put pressure on price once again. Private buyers are avoiding bulk buying right now. It is being traded at Rs 3700 in Indore. Recent rains in Rajasthan & Haryana are said to be beneficial for Chana crop. It may push up yield further. Crop condition is satisfactory so far. Pressure is likely to continue on Chana.
- **Nafed procured 53450.598 MT Tur from kharif 2017-18 on MSP of Rs5450 till 20 Jan-2018.** Karnataka procured 19946.226 MT and Telanga procured 33504.37 MT Tur. Telangana has met its procurement target. Burma offers new lemon tur at \$370 per tonne while old crop is being offered at \$335 per tonne basis Indian port. Likely is being offered at \$350 per tonne. In INR terms it comes to 23635 per tonne for new and Rs21400 per tonne for old crop. Despite parity import is not possible due to import quota restriction (2 lakh tonne). Restriction on quota is likely to continue until tur price touches its MSP level of Rs 5450.
- **Rabi pulses sowing area is running ahead by 4.72 % to 163.11 lakh ha as on 19th Jan-2018.** Chana area was registered at 106.23 against 98.47 lakh ha. Masur area was registered at 17.27 against 17.21 lakh ha, peas area was recorded at 11.85 against 11.88 lakh ha. Even Urad and Moong area was recorded at 7.91 against 8.42 & 5.77 against 5.68 lakh ha. Other pulses area was recorded at 6.06 against 6.21 lakh ha. Overall sowing progress is running good. Bumper area coverage is on the card once again.
- **New crop of Lentil is round the corner and slightly higher area coverage (0.22 %) to 17.19 lakh ha so far and good growth, flowering of early sown crop till now indicates good crop size this year.** Production is estimated around 11.5 to 12 lakh tonne this year, 1 lakh tonne higher than last year. Import continues in spite of 30 % duty. New crop is expected by end February, hardly one month away from now. So improvement in lentil market is unlikely. Govt would procure limited quantity during peak arrival season at Rs 4250 including bonus of Rs 100 per qtl. Current market is ruling below Rs500/600 per qtl from MSP. Likely pressure from new crop would continue to weigh on market fundamentals.
- **Canadian Masur in Mumbai is being offered at Rs3400/3550 per qtl.** Australian container (lentil is being offered at Rs3600-3700 per qtl at Indian port. So pressure is likely to continue on lentil market. Opening of export is not much helpful as parity is not in favour of India. Crop condition in UP and MP is good so far.
- **South Indian importers imported 411 containers pulses during 15th Dec to 04th January-2018.** They had imported 395 containers during fortnight 30th Nov to 14th Dec-2017. Chickpeas import was registered at 219 containers against 109 imported during previous week. Lentil import decreased from 143 to 29 containers during the review period. Green Peas & Urad import was registered at 29 against 41 containers while Urad import was registered at 59 against 61 containers. Whole Tur import was reported at 9 against 10 containers during review period. Yellow pea import too decreased from 21 to 14 containers.
- **Karnataka govt. had purchased 2.4 lakh tonne Tur last year. This year purchased target has been fixed at 1.65 lakh tonne.** State govt. has purposed to give bonus of Rs 500 per qtl. over & above MSP. This means farmers would get Rs 5950 per qtl. for their Tur. Karnataka govt. would procure 20 qtl. from each farmer. It would support market to a certain extent at current level. Tur MSP is Rs 5450 including bonus of Rs 200. It would restrict downward trend despite new arrivals.

Pulses International Fundamental:

- **Lentil crop in US, Australia & Canada is considered lower than last year record.** However, it is still higher than average. Record crop in India last year and almost record production likely this year too have encouraged govt. to impose curbs on import and it started affecting normal demand from India and its impact on price too. Canadian farmers are beset of huge lentil stock of 2017. It would continue to weigh on market fundamentals.
- **Lentil ending stock in 2016-17** was recorded at 4 lakh tonne. It will move up to 7.8 lakh tonne in 2017-18, almost double from last year. Against this stock to use ratio is only 36%.
- **Chickpea production is estimated at 97100 tonne in 2017-18 in Canada.** All peas production was estimated at 41.12 lakh tonne. Export has been estimated at 25.20 lakh tonne in 2017-18.
- **Lentils area in Canada is bound to decline from 23.72 to 17.43 lakh ha in 2017-18.** It is lower by 23.54 % from last year. Yield is expected to improve from 1.45 to 1.55 t per ha. Total production is expected to decline by 16 % from 32.48 to 27.25 lakh ha. As production would decline, total supply would decline by 10.43 % to 30.35 lakh t. Average price in 2017-18 may rule in the range of C\$720 to 750 per T.
- **Green Lentils market remains unaffected from USDA 's final production estimate** for 2017 and stock available on 1st December-2017. Available stock on 1st Dec was reported at around 1.9 lakh tonne, lower from 2.38 lakh tonne from Dec last year-2016. Production was estimated at 3.39 lakh tonne in 2017 against 5.75 lakh tonne in 2016. However, market participants are not comfortable with this estimate.
- **Chickpeas production estimate for the US has been increased from 2.50 lakh tonne (2016) to 3.15 lakh tonne in 2017** despite lower area coverage of 6.23 lakh acres. US farmers had covered 3.31 lakh acres in 2016. However, Chickpeas stock on 1st Dec-2017 was recorded at 72000 tonne, lower from 65000 tonne from Dec-2016. Small Chickpeas stock was recorded at 45750 tonne against 32600 tonne last year. It's a tentative fig. Combined stock is higher by around 20,000 tonne from 2016.
- **Chickpeas production in Australia is expected to decrease by 47.85 % to 10.45 lakh tonne in 2017-18** from record 2004 lakh tonne 2016-17. Despite 4.43 % higher area coverage, production is bound to decrease drastically due to hot and dry weather condition prevalent in the major growing regions. Chickpeas area increased from 1069 to 1144 thousand ha in 2017-18.
- **Imposition of import duty on all peas by 50 % has started impacting export** volume from Canada. According to Agriculture and Agri-Food Canada Peas export would decrease from 3.9 MMT (2016-17 to 2.4 MMT in 2017-18. Lower export volume would increase carryout around 5 lakh ton, higher than normal expectation. Yellow peas price are hovering in the range of C\$5.00 to C\$6.50 a bushel in western Canada.
- **Lentils production in Australia too is bound to decline from 8.3 to 4.19 lakh tonne in 2017-18.** It is almost 50 % down from last year. Lentils area was reported higher by 16 % at 3.55 lakh ha. Due to rough weather condition Lentils production would decline to 4.19 lakh tonne. Even field peas production is bound to decline by 32.47 % to 2.8 lakh tonne in 2017-18. Australia had produced 4.15 lakh tonne field peas in 2016-17.
- **AAFC (Canada) has revised down peas production estimated from 42.50 to 41.12 lakh tonne for 2017-18.** In last one month production estimate has been revised down by 1.70 lakh tonne for next season crop due to lower prevailing price and weak demand from India and Pakistan. Canada had produced 48.36 lakh tonne peas in 2016-17.
- **Peas import from Ukraine to India is bound to increase over 50 % to 6.5 lakh tonne in 2017-18** as bumper production seems very much on the card. Ukraine produced 7.45 lakh tonne peas last year.

Weekly Outlook: -Pulses are likely to trade range bound to slightly weak except Tur in the near term.
