

Pulses Domestic Fundamentals:

- **Chana market traded under pressure on subdued demand and weak inner tone.** Supply side is adequate and slower pace of buying by govt's agencies, private trades limited buying and crunch of money are impacting cash pulses market. Chana in Delhi market traded down by Rs 50 to Rs 3800 per qtl.
- **Central govt has approved to procure one lakh tonne Urad and 32 thousand tonne Moong in Andhra Pradesh from rabi season 2018 on MSP through govt.'s procurement agencies.** Tamil Nadu govt would procure 3000 metric tone Urad from Rabi season.
- **There is a rumour in the market that 50 containers Tur and Urad are being loaded in Burma for India.** It is likely to hit Indian ports by the end of next week. As per current quota 2 lakh tonne Tur and 1.5 lakh tonne urad & moong each can be imported.
- **Moong import is possible despite quantity restriction at 1.5 lakh tonne for the year.** Prices of Moong in domestic market is hovering in the range of Rs 4800-5000, while Mozambique and Burma are offering Moong at \$545 & \$690 per tonne against Indian prevailing price of \$730-740 per tonne. In INR term Mozambique Moong comes to Rs 35360 per tonne while Myanmar Moong comes to 4475 per qtl. If prices continues to move up, import may take place. Govt has not issued any notification regarding quantity restriction as of now. If there is no notification; this means 1.5 lakh tonne import is possible. As new rabi crop is coming into mandis, import may take place in June onward.
- **Pea Arrival from producing regions is decreasing continuously and there is no import deal right now** due to 50 % import duty on all peas. As domestic price of matar (peas) is cheaper, importers are waiting for parity. Demand for besan and pea are good and there is no import in next two months, it would drive domestic price of matar up. The firmness would continue till domestic price come at par with imported pea price.
- **Arrival in two major producing states like MP and Uttar Pradesh has declined.** Production size is almost normal of 9 lakh tonne in India. against consumption of 25 to 27 lakh tonne annually. Imported stock too have started declining now. In Mumbai at port pea is being traded at 3300-3350 per qtl. in Kanpur market it is being traded at Rs 3200-3250. Against it if matar imported at current duty, it would cost Rs 3600 per qtl. So Matar price is bound to go up By Rs 300 more from current level.
- **Nafed will procure 450930MT Chana in Madhya Pradesh during rabi season 2017-18** at MSP from farmers. Chana procurement in Gujarat would commence from 20th April-2018. Odisha govt. has approved Urad, Moong and Tur from farmers on MSP. Markfed will procure pulses in the state.
- **Nafed procured 157320.308 MT Chanaas on 4th April from rabi 2017-18 at MSP.** Out of total maximum quantity (73399.92 MT) has been purchased from Karnataka, followed by Telangana , which has procured 39779.30 MT so far. AP has procured 24482.75 MT, Rajasthan has purchased 11465.37 Mt & Maharashtra procurement was recorded at 8193.10 MT. Procurement continues.
- **In a latest development govt of India has approved purchase of 1.2 lakh MT chana and 1.2 lakh MT masur in Uttar Pradesh on MSP during rabi season 2017-18 to support cash market and ensure MSP to state farmers.**
- **DGFT removes mandatory roasted chana/ chana dal exportin consumer pack of one kg.** Now it can be shipped in bulk. Now all pulses are free for export. Exporters have started making network in overseas market for export.
- **Nafed procures 678101.10 MT Tur till 4th April-2018 from kharif 2017-18 crop.** Out of total procurement Maharashtra contributed 198602.81MT, Gujarat contributed 13098.42 MT, Karnataka procured 335499.88MT, Andhra Pradesh procured 55600 MT and Telangana procured 75300 MT on MSP.
- **New Urad crop from Rabi season is likely to commence soon in AP.** Rabi Urad and Moong crops are said to be in good condition in AP & Telangana. As demand continues, any major impact on price is unlikely. However, it would continue to restrict any firm move in the short to medium term.
- **Procurement of Chana in Rajasthan commences.** State govt has decided to procure 4 lakh tonne chana at MSP in the state.

Pulses International Fundamental:

- **Lentil export from Canada has badly affected due to absence of India in global market** and imposition of 30 percent duty in India. During the month of March-2018 Canada exported only 23000 MT. During last eight months from August to March-2018 total lentil export recorded only at 2 lakh tonne against 667,400 tonne exported during same time span last year. It seems that season would end with below 4 lakh tonne export. After 2012-13, it would be the lowest one.
- **US farmers have decreased lentil area due to poor demand and bearish global market.** US farmers had planted 1104 thousand acres under lentil in 2017. This year lentil area has decline by 28 % to 791 thousand acres. Area under lentil in all major producing states like Idaho, Montana, North Dakota and Washington has declined by 69, 73, 77 & 82 % respectively this year against last year.
- **After two consecutive bumper crop years of pulses in India, prices of pulses decreased** below MSP level and pressure is still on. So Indian govt is unlikely to increase import quantity in the first half of the current MY, starting from April. Farmers in Myanmar may decrease area under Moong and Urad this year and may shift to other alternate crops as prices are much below the production cost. Myanmar govt is planning to buy Moong to support farmers.
- **Global lentil market traded unchanged during the week under review. Weak demand from India and other importing nations has pressurized the Canadian lentil market too.** Lentil export from Canada has been decreasing continuously. In the first half of MY 2016-17 only 26% of the opening season supply of lentils was exported. It is down by 51% from last season and 59% during the first half of the 2015-16 marketing year.
- **India & Canada have agreed to solve fumigation issue by the end of this year.** PM of both the countries have announced that India and Canada will work closely together to finalize an arrangement within 2018 to enable the export of Canadian pulses to India free from pests of quarantine importance, with mutually acceptable technological protocols. However, no statement has been made over import duty ranging from 30 to 50 % applicable right now.
- **Pulse Australia has signed an agreement with Indian Pulse and Grain Association (IPGA)** for greater exchange of information on Indian pulse crops. IPGA says that better exchange of market information will benefit producers and the operation of the supply chain. Insight into pulse crop developments in India is especially important, given the global status of India in pulse markets—says Pulse Australia CEO, Nick Goddard.
- **Lower demand from major importing countries lentil and peas area has declined** in Canada this year. Lower export volume from Canada also hints weak demand and it is likely to continue in 2018 too. Farmers in Canada had covered around 10 million acres in 2016, which was around 40 lakh acres higher than 2013-14 crop year. This year total area declined to 85 lakh acres. Under lentil crop around 44 lakh acres has been covered while pea area was reported at 41 lakh acres. Despite lower area coverage in 2017, it is second largest area coverage. So supply side is unlikely to be tight this year.
- **Canada Lentil ending stock in 2016-17** was recorded at 4 lakh tonne. It will move up to 7.8 lakh tonne in 2017-18, almost double from last year. Against this stock to use ratio is only 36%.
- **Chickpea production is estimated at 97100 tonne in 2017-18** in Canada. All peas production was estimated at 41.12 lakh tonne. Export has been estimated at 25.20 lakh tonne in 2017-18.
- **Lentils area in Canada is bound to decline from 23.72 to 17.43 lakh ha in 2017-18.** It is lower by 23.54 % from last year. Yield is expected to improve from 1.45 to 1.55 t per ha. Total production is expected to decline by 16 % from 32.48 to 27.25 lakh ha. As production would decline, total supply would decline by 10.43 % to 30.35 lakh t. Average price in 2017-18 may rule in the range of C\$720 to 750 per T.
- **Chickpeas production in Australia is expected to decrease by 47.85 % to 10.45 lakh tonne** in 2017-18 from record 2004 lakh tonne 2016-17. Despite 4.43 % higher area coverage, production is bound to decrease drastically due to hot and dry weather condition prevalent in the major growing regions. Chickpeas area increased from 1069 to 1144 thousand ha in 2017-18.
- **Lentils production in Australia too is bound to decline from 8.3 to 4.19 lakh tonne** in 2017-18. It is almost 50 % down from last year. Lentils area was reported higher by 16 % at 3.55 lakh ha. Due to rough weather condition Lentils production would decline to 4.19 lakh tonne. Even field peas production is bound to

decline by 32.47 % to 2.8 lakh tonne in 2017-18. Australia had produced 4.15 lakh tonne field peas in 2016-17.

Weekly Outlook: -Pulses are likely to trade steady to slightly weak.
