

Pulses Domestic Fundamentals:

Today's Update:

- **After the latest decision of Madras High Court on pea import, retained at ports, might be released soon. Notably, the honorable court had green signaled to release imported peas from ports with condition of 10% bank quarantte. Market sources say that around 1.04lakh tonne pea is available at ports.The maximum quantity is at Chennai ports(55000 MT). At Mundra and Kolkatta ports the quantity in question is said to be around 32000 and 10000 MT respectively. If we add containers quantity too, total availability of ea at port is 1.04 lakh tonne.**
- **Govt has released 2nd Adv. estimate for foodgrains on 28.02.2019. As per the latest adv estimate tur production has been pegged at 3.68 million tonne against target of 4.5lakh tonne for 2018-19. For chana it has been pegged at 10.32 million tonne against target of 11.50million tonne .Urad production has been estimated at 26.8 in kharif and 0.69 in rabi season. Total production has been pegged at 3.36 million tonne. For moong it has been pegged at 2.41 million tonne including 0.57 million tonne rabi. Lentil production has been pegged at 1.53 lakh tonne. Total pulses production has been pegged at24.02 million tonne.**
- **DGFT has separated HS code for moong and urad now. Before this HS code for urad and moong was 07133100. Now it is 07133110 for urad and 07133100 for moong. Actually, it would make it easy to quantify import-export of both commodities now.**

Previous Update:

- **Overall rabi area is unlikely to match last year's level as sowing is almost over now for chana, lentils and pea. Urad and moong sowing would continue. Rabi pulses area decreased by 5.74 % at 157.67 lakh ha against 166.58 lakh ha last year as on 22nd Feb-2019.Chana area is lagging by 10.02 % at 96.59 lakh ha against 107.57 last year. Farmers have covered 1.72 % lower area under lentil so far at 16.93 lakh ha against 17.25 lakh ha last year. Pea area is up by 11.36 % at 10.45 lakh ha. Urad area is lagging by 10.83 % at 9.71 lakh ha against 10.07 lakh ha last year. Moong area too is down by 6.12% at 8.55 lakh ha against 8.96 lakh ha so far.**
- **Despite ongoing procurement drive and lower crop size tur market remains under pressure due to weak demand and availability of old crop at lower level. Stockists are releasing old crop. Tur market may dip by Rs 100-150 further as arrival is major markets are increasing. Overall view for tur market remains firm and it would move up again in the medium term.In Gulberga market Tur is being traded at Rs 5000 to 5300 while in Mumbai it is being traded at Rs4900-5000.On going procurement drive remains supportive.**
- **Telangana govt has procured 70,300MT tur so far, while Karnataka has procured 52833.04MT, Gujarat 835.33MT,Tamil Nadu 51.55MT &Maharashtra 1051.99MT so far. Total procurement from kharif-2018 has reached at 125137.44MT as on 21st Feb-2019. Maharashtra Govt would procure 2.5lakh MT tur this year.**
- **Chana markets seems under bears grip and cash market continues to reel under pressure. Buyers are inactive at current price while sellers seem active despite lower projected crop size this year. New arrival is expected to increase in MP, Rajasthan from Mid-March and it would pressurize market further. However, lower crop size and likely improvement in demand from mid-March, supported by procurement drive may push chana price up in cash market from mid March. Buyers should buy around Rs4000 and hold it for two-three months. In normal condition market would move to Rs4500-4600 in April/May.Import is not possible. Sudan offers chana at Rs3900 at Indian port and some buyers are active.It hints market to move up again.In Delhi market chana is being traded at Rs 4200-4300. It may come down to Rs4000-4100 in March.**
- **The Madras High Court completed hearing on importers plea against DGFT order over restriction on pulses import yesterday .It is said that court has allowed pulses importers to take delivery with10% bank guarantee of invoice value. The court will give its final order on Monday. As per cleaning agent custom would take time of around8 o 10 days to complete delivery procedure.**

- **India imported 23667.99 MT chickpea in Jan-2019, down by 4.98 % from Dec-2018.** Chickpea has been imported at an average monthly CiF of \$617.39 per MT. India had imported 24908.95 MT in Dec. Total chickpea import from March-18 to Jan -19 was registered at 140664.6 MT. Against it export was registered at 274201.15 MT in last 11 months.
- **Urad import in Jan-2019 increased from 42860.81 to 58043.54 MT, up by 35.42 % from Dec-2018.** From Aug to Jan-2019 India imported total 339965.28 MT urad at an average monthly CiF of \$634.19 per MT. It has been imported at \$632.06 per MT in Dec. Urad import has already crossed fixed limit of 1.5 lakh tonne. However, the volume is likely to decline now as clearance at port is difficult now.
- **Govt. has given approval to buy 34500 MT chana under PSS in Telangana state.** Procurement in this state would continue till March-2019. It has commenced from 1st Feb-2019. For Telangana 159.39 crores have been allocated for chana farmers. Pressure on chana market continues and recovery in production in MP and Rajasthan seems very much in sight due to recent rains, lower temperature in night. Procurement activities in other states too may restrict downward trend. Overall trend in chana cash market is bearish. Pressure from new crop from MP and Raj might be felt from Mid March.

Pulses International Fundamental:

Today's Update:

- **Chickpea export from Argentina increased in Jan-2019 in comparison to Dec-2018 as per latest update by Instituto Nacional de Estadística y Censos.** It has exported 7,559 MT in Jan against 5233 MT in Dec. Thus total sales during the MY reached to 141309 MT. However, it is lower by 15% from last year. UAE brought 1,698 MT, followed by Spain at 1,098 MT. Other countries have brought 1,824 MT.
- **Canada & US are going to object import restriction imposed by India in WTO.** As per Commerce Ministry Official both the countries are against the quantitative cap on pulses imports. This is the second objection in WTO against India. Earlier, both the countries had objected under-reporting of market price support for five varieties of pulses under the minimum support.
- **Chickpeas production in Canada is expected to decrease from 311 to 130 thousand tonne in 2019-20.** Area under chickpeas too may decline from 176 to 74 thousand ha in 2019-20. Import is expected to decline from 25 to 18 thousand tonne. Thus total supply would decrease from 350 to 343 thousand tonne. However export volume may increase from 90 to 100 thousand Tonne. Carryout stock is expected to decline from 195 to 175 thousand tonne in 2019-20. Price is expected to hover in the range of \$520 to 550 per MT as per Statistics Canada and Agriculture.

Previous Update:

- **Lentil production in US is slightly down to 381384 MT against 339381 produced last year.** Earlier USDA had projected 398384 MT. Despite lower area coverage by 1.1 million acres, production increased due to better growing condition this year. Average yield increased from 678 pounds per seeded acre to 1,078 pound per acre. US mostly produces green lentil and it is facing challenge due to surplus production in Canada and other parts of the world.
- **Stock of lentil and field pea is comparatively higher in Canada.** At the end of 2018 stock of lentil in Canada was 2.04 MMT and field pea at 2.5 MMT as per statistic Canada. Data released on 5th Feb-2019 shows that lentil stock in Canada was down slightly from 2.11 MMT for lentil and from 2.82 MMT for Pea compared to 2017. Relatively higher stock for 2019 would continue to pressurize lentil price in world market in absent of big market like India. Trade volume remains thin.
- **Stock of lentil and field pea is comparatively higher in Canada.** At the end of 2018 stock of lentil in Canada was 2.04 MMT and field pea at 2.5 MMT as per statistic Canada. Data released on 5th Feb-2019 shows that lentil stock in Canada was down slightly from 2.11 MMT for lentil and from 2.82 MMT for Pea compared to 2017. Relatively higher stock for 2019 would continue to pressurize lentil price in world market in absent of big market like India. Trade volume remains thin.
- **As per latest update by Canadian lentils Agriculture, Canada is expected to produce 2 MMT of lentil from 1.35 million hectares in 2019-20 MY compared to 2.09 MMT from 1.52 million hectares.** Domestic consumption is expected at 0.48 MMT. Exports are expected to touch 1.8 MMT in 2019-20 MY compared to 1.53 in 2018-19 MY.

- Chickpea export from Russia increased from 9104(Oct) to 19,326 metric tons in Nov. However, it was down by 28% in this calendar year to 78,889 MT from last year till Nov-2018.Pakistan, Turkey and Jordan were major buyers. They brought 61674668 and 2,547 MT so far.**
- Pea Export from Russia increased from 65,578 MT to 78,295 MT in Oct. This lifted export sales so far during the calendar year to 967,095, up 14% last year. The major importer for the month was Turkey- 17,069 MT. Latvia-15,975 MT and Spain - 15,362 MT.**
- Chickpea production in Australia has been forecast at 330 thousand MT for 2018-19 against 1148 thousand produced in 2017-18.Faba bean production too has been estimated at 214 thousand MT against 330 last year. Field pea production has been pegged at 194 thousand MT against 289 in 2017-18.Lentil production estimate too has been pegged at 343 thousand MT against 485 thousand MT. However, Lupins production estimate has been pegged higher at 710 thousand MT for 2018-19. It was 631 last year.**
