

Domestic & International Market Highlights:

- On March 03, under the FCI OMSS scheme, 50 metric tonnes of rice were sold from Maharashtra at a price of Rs 2,250 per quintal. FCI sold 1,000 metric tonnes of rice from Jammu and Kashmir at Rs 2,000 per quintal on March 03 under the OMSS scheme.
- The Ministry of Food has proposed cutting the import duty on rice further by 10 per cent to 15 per cent with a view to encouraging traders to import the staple in higher volume. The meeting also considered reducing import duty on coarse white rice (coarse atap) to 15 per cent from the 62.5 per cent. In December, the government cut the duty rate by 37.5 percentage points to 25 per cent on import of parboiled rice. The duty on rice import was increased to 62.5 per cent earlier to discourage rice imports and benefit local farmers.
- Food assistance of 1000 tons of rice from Madagascar to India: India has decided to give one thousand tonnes of rice and one lakh anti-malarial tablets to Madagascar, a country located in the Indian Ocean, as humanitarian aid. Madagascar is facing severe drought crisis this time. Similarly, 1000 tonnes of rice will be given to another country - Comoros. Clove is produced on a large scale in both these countries. India is providing this first aid to it.
- As more buyers from South America, Eastern Africa and South East Asia start queuing up for the Indian rice, the exports of the rice for both basmati and non-basmati are seen scaling new highs this fiscal. Rice exports including both basmati and non-basmati types are expected to range between 16 and 17 million tonnes (mt) against previous fiscal's 9.48 mt. South American buyers such as Peru and Argentina have recently granted market access to the Indian basmati rice. Similarly in Eastern Africa, countries such as Angola and Tanzania among others, who traditionally bought from Pakistan, have now turned to India, while Far East countries such as Vietnam and Cambodia are showing higher interest.
- As per second advance estimate by Agriculture Department of India, Indian rice production in MY-2020-21 is expected to reach to 120 Million tonnes which is a record till now.
- Paddy procurement for Kharif 2020-21 is continuing smoothly in the procuring States & UTs of Punjab, Haryana, Uttar Pradesh, Telangana, Uttarakhand, Tamil Nadu, Chandigarh, Jammu & Kashmir, Kerala, Gujarat, Andhra Pradesh, Chhattisgarh, Odisha, Madhya Pradesh, Maharashtra, Bihar, Jharkhand, Assam, Karnataka, West Bengal and Tripura with purchase of over 651.07 LMTs of paddy up to 19.02.2021. This is an increase of 15.91 % against the last year corresponding purchase of 561.67 LMT. Out of the total purchase of 651.07 LMT, Punjab alone has contributed 202.82 LMT which is 31.15 % of total procurement.
- The Rice Exporters Association (TREA-India) is exporting the rice that is beyond the handling capacity of the Kakinada Anchorage Port operated by the A.P. Maritime Board. The first consignment of 32,250 metric tonnes of broken rice has started from Kakinada Deep Sea Port to Senegal in West Africa.
- In Bihar, over 30 lakh metric tonnes of paddy have been procured from farmers of the state this season. In February last year, paddy procurement was only 4.64 metric tonnes. Four thousand eight hundred 71 crores have been paid to over four lakh farmers for procurement of paddy this year. Chief Minister Nitish Kumar has instructed district authorities to speed up procurement.

February 21 is the last date for procurement of paddy. The state government has set a target to buy 45 lakh metric tonne paddy from farmers.

- In Karnataka, State Cabinet sub-committee on fixing support prices for farm commodities in principle approved procurement of 12.1 lakh tonnes of paddy. The minimum paddy procurement has been fixed at 25 quintals per acre and there is no maximum limit. Due to the shortage of containers, the European Union reduced the import duty on brown rice imported in March. According to the import scenario, now tariffs of 30 Euro / ton, 50 Euro / ton and 65 Euro / ton will be imposed on Brown Rice. If the import of brown rice was 191113 tonnes, it would attract a duty of 30 euros. If more than this was imported, 50 and above would attract a duty of 65 euros / tonne. From September 1 to February 9, European countries imported 1.36 lakh tons of brown rice (other than basmati rice).
- 'Maa' scheme' was launched in West Bengal before the assembly elections under which rice, wheat, vegetables and egg curry will be given for 5 rupees. This would impact the price in coming months in the state.
