

#### **Latest Market Development**

Wholesale Prices for India as an average for first week of February traded firmed by 4.48% and are currently hovering at Rs.2890-2895/quintal. Agriwatch expects non-basmati rice market to move range bound with firm tone in coming week.

Wholesale basmati rice prices in the national capital have declined this week due to a slackened demand from retailers. Currently hover in the range of Rs.41-4200 for 1121 sella and Rs.5100-5150 for steam. Overall basmati rice is expected to trade range bound in coming weeks.

**Total rice exports for MY-2016-16 till January-16 was 38.76 Lakh tons** around 9.43% lower than export of 42.8 lakh tons during corresponding period of last year. Non- basmati rice exports in the month of January was 5.00 lakh tons and basmati exports in the month was 3.08 lakh tons.

The Indian government will likely soon strike a one million tons rice export deal worth Rs.3, 000 crore (around \$443 million) with Indonesia.

The Agricultural and Processed Food Products Export Development Authority (APEDA) has urged the Commerce Ministry to include packaged basmati rice in the Merchandise exports from India Scheme list to help boost the country's basmati rice exports.

As per preliminary reports received from the States, the total area sown under Rabi crops as on 28th January, 2015 stands at 591.51 lakh hectare. Wheat has been sown/transplanted in 292.52 lakh hectares, pulses in 139.08 lakh hectares, coarse cereals in 60.08 lakh hectares & Rice is 22.41 lakh hectares against 24.08 lakh hectares in 2014-15.

In KMS 2015-16, FCI and other state agencies has procured about 24.47 million tons of Rice which is up by 24% from last year as of February-01-2016. Punjab, Haryana and Chhattisgarh are the main contributors with contribution of 49%, 15% and 12% respectively.

India's rice stocks in the central pool as on January 1, 2015 stood at around 26.02 million tons up by about 14% from around 22.37 million tons recorded during the corresponding period last year, according to data from the Food Corporation of India (FCI). India's rice stocks in the central pool are up about 10% from around 23.41 million tons recorded on December 1, 2015. The current rice stocks are about one million tons more than the required strategic reserve norms of around 10.25 million tons for this time of the year, according to the FCI.



Total Rice exported from India in month of January was 8.08 lakh tons out of which basmati rice contribute 38.12%, and non-basmati rice is 61.87% in this period with quantity of around 308429.99 tons and 500495.44 tons respectively as per latest data extract from IBIS. Major importers of Indian Basmati rice in this period were




UAE, Saudi & Iran. We expect Middle East countries to remain the major basmati buyers of Indian Basmati from Mundra, Kakinada and Kandla Port in coming months. Major non basmati importers were UAE, Guinea and Iraq. Monthly rice exports were down by around 45% from last month export of 14.71 lakh tons.

## **Major Non-Basmati Export Sourcing Center**





**Major Basmati Export Sourcing Center** 






All-India progressive procurement of Rice as on 22.01.2016 for the marketing season 2015-16, was 229.35 lakh tons against the procurement of 178.11 lakh tons up to corresponding period last year. Rice procurement is up by around 29% from last year due to lower open market price which did not meet the farmers' expectations and also timely harvest mainly from northern states. In Punjab, which contributes the highest volume of rice and wheat to the central pool, the FCI and the state agencies have contributed around 49% till date, higher by 20% from last year.

## FOB Quotes Aromatic Rice (1121 Steam)



Indian FOB for 1121 steam in the month of January moved down from last month and currently is in the range of USD 805-810/MT which is down by around 7.43% from last month price. Average basmati rice price declined due to slackened demand from retailers against adequate supply push the price in southward direction. Pakistani





basmati price has increased from USD 716/MT to 734\$/MT, according to the UN's Food and Agriculture Organization (FAO). Currently Pakistani basmati FOB is hovering in the range of USD 716/MT which is up by 2.47% from last month FOB of USD 716/MT.

## **Global Updates**

The Thailand government plans to sell 570,000 tons of rice from its stockpiles on February 16 and 17. Thailand has signed four agreements to sell about 300,000 tons of rice worth 4.3 million baht (about \$121 million) to Iran in 2016.

**During the period January 1 – January 28, Vietnam exported about 314,706 million tons of rice, an increase of about 43% from** in January 2015 but about half as much as exported in December. The average export price so far in January stands at about \$404.5 per ton, down about 10% from a year ago and down about 1% from a month ago. In 2015, Vietnam exported about 6.62 million tons of rice, an increase of about 5% from 2014. Asia accounted for about 78% of Vietnam's total 2015 rice exports.

The government of Bangladesh plans to sell about 1.5 million tons of rice and wheat at reduced prices through open market sales program as the harvest time for 201516 Boro rice crop (JanuaryMay) nears. The USDA Post forecasts Bangladesh's MY 201516 (MayApril) milled rice production at about 34.6 million tons, up slightly from last year's numbers and unchanged from USDA's official estimates.

The Agriculture Secretary of the Philippines estimates 2016 paddy rice production will fall below the 2015 level of about 18.15 million tons due to the prevailing drought conditions. The USDA Post forecasts Turkey's MY 201516 (September/August) to be around 330,000 tons, up about 4% from in MY 201415 and unchanged from the USDA's official estimates.

The USDA Post forecasts South Korea's MY 201516 (November/October) imports to be around 470,000 tons, up slightly from last year's imports but unchanged from the USDA's official estimates.

The USDA Post estimates South Africa's MY 201516 rice consumption to increase about 10% y/y to around 970,000 tons, due to drought reflected record corn and wheat prices. This could be good opportunity for India to export more rice to South Africa in 2015-16.

## **IGC Rice Balance sheet Highlights**

Projected global rice output is cut on slightly reduced prospects in some producers, mainly in the southern hemisphere, but, at 473m t, would be only 1% lower y/y. While the outlook for rice use is maintained, a higher figure for carry-in stocks results in a small upward revision to end-season inventories, to 94.7m t. However, this is still a drop of 12% y/y owing to depletion in key exporters. The outlook for trade in 2016 is little changed, at close to 42m t, underpinned by demand from Asian importers.

#### **USDA & IGC Forecast the Same World Rice Production**

In its January 2016 Rice Outlook report, USDA also forecasted 2015-16 global rice production (milled basis) at around 473 million tons, about 1.5% lower than last year. Disappointing crops in some producing nations – including India and Thailand, only partly offset by improved harvests elsewhere in Asia, and an expected decline in acreage as well as decline in average yields, are likely to be affected by adverse weather conditions. It forecasted 2015 global rice trade at around 42.4 million tons, down 2% from an estimated 43.2 million tons in 2014

## Global Trade of Rice Unchanged from Last Month

The IGC forecasts 2015-16 global rice trade at around 42 million tons, unchanged from the previous year's 42 million tons as well as its previous estimate of around 42 million tons.
