Fundamentals:

Today's Update:

- Steady sentiments reported in Red chilli cash markets on Wednesday.
- Current year total red chilli supply in Guntur market from 1st January 2019 to 15th March 2019, stands at around 153,675 MT as compared to 118,575 MT in the corresponding period last year, supply up by 29.6% an expectation of higher production current year.
- As per trade information, chilli cold storage stocks as on date (including old and new crops) in Guntur stood at 112,500 to 121,500 MT according to various trade estimates.

- Export demand reported well from Sri Lanka, Malaysia, Bangladesh and UAE etc.
- In Andhra Pradesh, Chilli sowing for the Rabi season as of 13th Mar reported at 14,385 hectare as compared to 20,453 hectare in the corresponding period last year. Normal area reported 25,950 hectare. Chili is at flowering to picking stage.
- Overall, the average rainfall received in Andhra Pradesh from 1-6-2018 to 13-03-2019 is recorded as 594.9 mm as against the Normal as on date of 873.8 mm showing by Deficit 31.9 percent.
- Continued buyers reported active for good quality hybrid variety like 334, Teja in spot market.
- As per Agriwatch's second advance production estimate, Red Chilli production for 2019-20 is estimated at 12.22 lakh MT. Previous year's production was 10.50 lakh MT.

Today's Update:

- Steady sentiments reported in Turmeric cash markets on Wednesday. Few markets closed due to Holi festival.
- In Nizamabad, current season new Turmeric arrivals reported around 34,580 MT till 15th March compared to last year same period 32,130 MT, 7.6% reported up from last year.
- In Nizamabad indicative market, for new crop as moisture percentage reported 10 12%.
- In Andhra Pradesh, Duggirala market new turmeric likely to enter last week of March or April first week. Sources revealed that, farmer are preparing fresh turmeric for boiling after that it will sundry for next ten to fifteen days.
- Current season new Turmeric arrivals reported around 26,740 MT till 08th March.
- In Erode mandi new Turmeric supply reported around on an average daily basis 2,500 2,800 quintals.
- Buyers were waiting for Maharashtra crop arrivals. Local traders are likely to become active in coming days at lower price levels as Maharashtra production estimate reported lower as a result of drought condition.

- Due to moisture content new crop supply buyers reported unresponsive.
- In some spot market, Turmeric prices traded at very low prices due to inferior quality arrival as a result of off season supply.
- Local traders are likely to become active in coming days at lower price levels as Maharashtra production estimate reported lower. As per market information, due to water scarcity standing crop growth is very slow.
- As per Agriwatch's Second advance production estimate, Turmeric production for 2019-20 is estimated at 532,353 MT (basis dry crop) compared to previous year's 476,771 MT. Turmeric production may go down further as Maharashtra standing crop is at very crucial stage.

BLACK PEPPER

Fundamentals:

Today's Update:

- Steady sentiments reported in Black Pepper cash markets on Wednesday.
- According to General Department of Vietnam Customs data, by end of February, Vietnam exported 34,794 tons
 of pepper, including 31,253 tons of black pepper and 3,541 tons of white pepper. Total export turnover reached
 101 million USD, black pepper reached 87 million USD, and white pepper reached 14 million USD.
- The average export price of black pepper in the first 2 months of the year reached 2,782 USD / ton, white pepper reached 3,958 USD / ton. Compared to the same period of 2018, export volume increased by 15.5% while export turnover decreased by 13.2%. Export price of black pepper decreased by 339 USD, white pepper decreased by 606 USD.
- The US continues to be the leading importer of pepper from Vietnam, in the first 2 months of 2019, the US imported 7,372 tons, an increase of 1,877 tons. China is the second largest import market with an increase of 613 tons from 3,650 tons to 4,263 tons. Followed by Ireland increased by 689 tons, the Philippines increased by 487 tons, South Korea increased by 417 tons, etc.
- Vietnam pepper price in the Central Highlands and the South moved averagely at VND 45,500 / kg.

- In 2018, as of November 2018, India exported a total of 754,102 Kg of green pepper, including from 664,119 Kg
 Dehydrated Green Pepper (DGP) and 89,983 Kg (FDGP-Freeze-Dried Green Pepper). This level shows a
 decrease of 8% in total exports of Indian green pepper compared to the previous year.
- In January 2019, Vietnam pepper export volume hit 15,000 tons worth US\$46 million, posting 19.6 per cent and 13.5 per cent increases in terms of quantity and value from the previous month.
- Vietnam average export price in January was US\$ 3,067 per ton, falling 5 per cent from December 2018 and 23.5 per cent from the same period last year.

- As per Agriwatch second advance production estimate Jeera production for 2019-20 is estimated at 385,334 MT (around 70 lakh bags) compared to previous year's 363,000 MT (66 lakh bags).

- As per Final Gujarat state govt. data, Jeera progressive area of Rabi 2018-19 is 347,539 hectares as on 11-02-2019 which is lower than 382,677 hectares during corresponding period last year. Till now 108.97% sowing completed from Normal area 318,926 hectares.
- Currently, all India stocks reported around 5 6 lakh bags (1 bag = 55 Kgs).
