Fundamentals:

Today's Update:

• By and large steady sentiments witnessed Red Chill cash markets on Tuesday.

- In Byadgi, new chilli arrivals reported around 50,000 bags, however mostly with high moisture and rain touch quality. As per trade sources, 20 30% rain touch medium quality reported.
- At Guntur spot market new crop arrivals reported around 15,000 17,000 bags from Kurnool, Prakasam regions with high moisture content, mostly rain touch quality; however good quality expected to start from mid January onwards.
- As we said earlier, stockiest should start to release their stocks before New Year.
- Redchilli prices reported down at Guntur market due to lower demand at higher levels. Expected higher
 production in coming marketing year is the main reason for prices correction. New crop supply slowly
 started with lower quantity and moisture quality, however good quality expected to start from January
 onwards. Agriwatch first estimates, Red Chilli all India production for 2021-22 is estimated at 13.84 lakh MT.
 Last year's production was 12.32 lakh MT.
- Teja variety prices reported down as buyers were not interested at higher prices in the spot market. Prices likely to correct in coming days.
- Due to this unseasonal rainfall new crop supply reported delayed by 15 20 days which supported the prices, but there is a decline in quality.
- Export demand from China and Bangladesh very less, however some fresh demand reported from Vietnam,
 Malaysia and Indonesia at Guntur market.

Today's Update:

- Steady to weak sentiment witnessed in Turmeric spot market on Tuesday.
- Due to higher stocks in the spot market buyers reported inactive.
- In Erode spot market, turmeric supply is arriving at an average of 2,500 2,600 bags daily.

- The farmers plan on releasing their stocks only at higher prices and buyers are not active at those prices.
- Turmeric buyers likely to become active from current price levels in coming days as market movement are increasing day by day.
- Agriwatch first estimates, Turmeric all India production for 2021-22 is estimated at 4.46 lakh MT. Last year's production was 4.53 lakh MT.
- We expect Turmeric prices may not go down below from current levels.

BLACK PEPPER

Fundamentals: Today's Update:

- Steady to weak sentiment witnessed in pepper market on Tuesday.
- As on 05th January, new pepper 500 G/L traded at Rs.31,900/-qtl, down Rs.100/qtl from previous day.
- Vietnam pepper prices today continued to go sideways around the average level of 53,500 VND / kg.
- Accordingly, the provinces of Dak Lak, Dak Nong, Ba Ria Vung Tau and Binh Phuoc have stable transactions in the range from 53,500 to 54,500 VND / kg. Particularly, Gia Lai increased by 500 VND / kg compared to yesterday, currently purchasing at 53,000 VND / kg with Dong Nai province.
- At the end of December 2020, export pepper prices in Brazil and Malaysia were stable compared to the end
 of November 2020. Meanwhile, India, Indonesia and China adjusted up again in the past month, the Import
 and Export Department reported.
- Specifically, in Brazil, the price of black pepper for export was stable at USD 2,800 / ton. At the Malaysian port of Kuching, export prices for black and white pepper respectively recorded USD 3,675 / ton and USD 4,900 / ton respectively. In contrast, the price of black pepper at the port of Kochi (India) increased 1.2% (equivalent to 55 USD / ton) to 4,825 USD / ton. At the Indonesian port of Lampung ASTA, the price of black pepper at the end of December 2020 was 3,000 USD / ton, a sharp increase of 14.9% (equivalent to 388 USD / ton) compared to November 2020.
- Similarly, at the port of Ha Khau (China), the price of white pepper for export on December 25, 2020 increased by 4.5% (equivalent to US \$ 225 / ton) compared to November 30, 2020, currently traded. around 5,275 USD / ton.

- According to Malaysia Pepper Council (MPB), during 2020, domestic and global pepper prices tend to be unstable. Total pepper output in 2020 is estimated at 30,000 tons, down from nearly 4,000 tons compared to 33,940 tons in 2019.
- Agriwatch estimate, pepper production in current year (2020) 65,000 tons which will be higher than last year (2019) 45,000 tons.
- As per trade sources, the total pepper output in the 2019-2020 crop year is estimated at 558,000 tons, still significantly higher than the total consumption demand of 496,000 tons.

- Higher production put cap on prices in the spot market.
- Jeera sowing finished in Gujarat and Rajasthan growing regions, current year area likely to go down by 15 –
 20% due to lower prices.
- Jeera traded till now in Gujarat in major market like Unjha, Rajkot, Patan, Dhrol, Gondal- around 83 85%.
- In Rajasthan Jodhpur, Nagaur- Harvesting has been completed, 85 87% traded, balance produce is in farmer's hand.
- In Unjha benchmark market new crop supply reported at around 1500 1600 bags on an average daily basis.

CARDAMOM

Fundamentals

Today's Update:

Steady to weak sentiments witnessed in Cardamom spot market on Tuesday.

- Buyers reported active in the spot market due to good domestic (20% reported increased) and international demand.
- Higher supply put cap on prices, however buyers likely to active from lower prices level.
- Cardamom crop reported damaged in Guatemala so international demand shifted to India supported the prices.
- New Cardamom supply continued to the market. Current year Cardamom production likely to go up due to favourable weather condition in Kerala and Tamil Nadu put cap on prices from higher levels.
- Expected higher production current year put cap on prices at higher levels.
- New marketing season has started from 1st August.
- Agriwatch estimates for 2020-21, India's Cardamom production would be around 22,000 23,000 MT, due to favourable weather conditions. Last year it was 19,000 – 20,000 MT.
- Current year due to lower production buyers likely to active in the spot market from lower levels.

CORIANDER SEED

Fundamentals: Today's Update:

• Steady to firm sentiment witnessed in Coriander spot market on Tuesday.

- Coriander sowing finished in Rajasthan, Madhya Pradesh and Gujarat growing regions. As per trade information, area may go down in MP and Rajasthan, however in Gujarat sowing area reported higher.
- We expect 2021-22 marketing year likely to be good for Coriander.
- Buyers are likely to be active at the current level or may wait for some correction, to go for active buying as ending stocks slowly come down.
- As per Agriwatch final production estimate, Coriander production for 2020-21 (marketing period) is estimated at 352,316 MT (88 lakh bags) compared to previous year's 268,957 MT (67 lakh bags, 1 bag = 40 kg).
- Though carryover stocks reported higher current year but ending stocks (AW estimate) for 2019-20 will be less compared to last three years likely to support Coriander prices in new season from lower levels.
