

RED CHILLI

Fundamentals:

Today's Update:

- Continued steady sentiment at higher prices reported in the Red Chilli spot market on Saturday.
- Due to Saturday weekly off major markets are closed today.
- As Red Chilli prices are continuously moving up from last few days farmer's sowing perception (regarding area shifting to other crop) is changing continuously. Red Chilli sowing will continue till August.

- Fresh export demand is continuing from Bangladesh, Indonesia and Malaysia at Guntur market supporting the prices. Red Chilli 334(S4) more demand coming from Bangladesh and masala millers from South India.
- As per AgriWatch estimates, Red Chilli all India production for 2022 is estimated at 14.07 lakh MT, revised after rainfall in Karnataka and virus affected in AP and Telangana. Last year's production was 13.84 lakh MT.
- As per Andhra Pradesh agricultural department, as on 20th July Red Chilli sowing activity completed around 5,275 hectares as compared to last year same period 4,404 hectares.
- As we expected earlier, Red Chilli prices is trading up amid good export demand, also stocks of premium quality are less likely to support the bullish prices in coming days. Demand from masala industry likely to support bullish sentiment.

TURMERIC

Fundamentals: Today's Update:

- Continued steady sentiment at higher prices has been recorded in Turmeric spot market on Saturday.
- Due to Saturday weekly off major markets are closed today.
- In Maharashtra heavy rainfall has been reported in the last few days in Turmeric key growing areas amid flash flood situations. It is likely expected that if rainfall would continue for the next few more days, waterlogging situations may likely arise and high risks of crop damage may be witnessed and yield may decline.

- As per Andhra Pradesh agricultural department, as on 20th July Turmeric sowing activity completed around 6,536 hectares as compared to last year same period 4,986 hectares.
- As per AgriWatch intention, current year Turmeric sowing area may go down in AP, Telangana and Maharashtra as other competitive crops like Cotton and Maize prices are comparatively higher and both crops are short duration crops.
- As per AgriWatch estimates, Turmeric all India production for 2022 is estimated at 4.67 lakh MT, revised after crop damage due to excessive rainfall in Maharashtra, AP and Telangana, earlier estimate was of 4.89 lakh MT. Last year's production was 4.46 lakh MT.

BLACK PEPPER

Fundamentals:

Today's Update:

- Steady sentiment was witnessed in Black pepper spot market on Saturday.
- Vietnam Pepper price as on 22nd July 2022 in the domestic market has a slight increase. Currently trading pepper around 67,500 71,000 VND/kg, increased by 500-1000 VND/kg compared to yesterday. Specifically, today's pepper price in Dak Lak and Dak Nong provinces is buying at 68,500 VND/kg; an increase of 500 dong compared to yesterday; Gia Lai pepper price increased slightly by 500 dong, trading at 67,500 dong/kg; Pepper price in Dong Nai today increased by 1,000 VND, purchasing to 67,500 VND/kg; in Ba Ria Vung Tau increased sharply to 71,000 VND/kg the highest purchase price of pepper in the country today; In Binh Phuoc, pepper price traded at 69,500 VND/kg, a sharp increase of 1,000 VND compared to yesterday.

- In June 2022, China imported 2,999 tons of pepper from Vietnam, higher than the total import volume from January to May of 2,619 tons. The total import volume of this country in the first 6 months of the year reached 5,609 tons, however, this import volume decreased by 80.2% over the same period.
- As per current situations, AgriWatch expected India's pepper productions for 2021-22 likely to go down by 8 to 10% compared to last year. Last year (2020-21) India's Pepper production was 62,000 MT.

Today's Update:

- By and large steady to firm sentiment has been observed in Jeera spot market on Saturday.
- Continued export to China with nominal quantities, however, Bangladesh and other countries are not active as prices are trading at an all-time high.
- AgriWatch expects demand likely to come up in domestic as well as in export markets in coming weeks.

- AgriWatch expects demand likely to be good in the spot market and buyers will be active in coming months as ending stocks for 2022-23 Marketing Year reported lower by 50.79%.
- As per the AgriWatch production estimate, Jeera production for 2022-23 (Marketing Year) is estimated at 316,281 MT (around 58 lakh bags each of 55 kg) compared to last year's 391,801 MT (71 lakh bags).
