

RED CHILLI

Fundamentals:

Today's Update:

- Steady to down sentiment was reported in the Red Chilli spot markets on Tuesday.
- As we anticipated earlier, increased arrivals in most of the cash markets reported today which has led to the corrections in most of the varieties in Red Chilli cash markets.
- Similarly, the Byadgi market saw a decrease in prices of Red Chilli Dabbi Dlx Local, which were reported to be between INR 43,000-51,000 per quintal, with a decline of 5.56%. On the other hand, due to an increase in demand from masala companies and millers for Red Chilli 5531 Best, resulting in a 5.88% rise in its prices, which were quoted at INR 14,000-18,000 per quintal compared to the previous day. Due to unfavorable weather conditions and heavy rainfall, which resulted in a decrease in the arrival of bags by 53,000, with the total number of bags amounting to 1,22,000.

Previous Update:

- Currently, good demand reported in the international market for Teja and 334 varieties of Red Chilli, especially from China, Malaysia, and Bangladesh. Teja variety is predominantly exported from the Khammam and Warangal markets, while the 334 variety is largely export from Guntur market, current season.
- As per AgriWatch estimates, Red Chilli all India production for 2023 is estimated at 15.56 lakh metric tonne (LMT). Last year's production was 14.07 lakh MT, up by 10.59%.

TURMERIC

Fundamentals: Today's Update:

- Steady sentiment was reported in the Turmeric Delhi spot markets on Tuesday.
- The Turmeric market has hit a three-week low and is currently trading at its lowest point in five months due to increased production this season.
- However, buyers in the global market, particularly from the USA and UK, are showing active participation
 in purchasing Turmeric, especially the powder variety, due to the lower price range as compared to the
 previous season. As a result, prices have stabilized and are expected to remain rangebound in the coming
 days.
- AgriWatch predicts that the arrivals will increase from this month (May) onwards, but this is not likely to significantly affect the prices since farmers and stockists are reluctant to offload their stocks at current levels in bulk quantities.

Previous Update:

• AgriWatch initial estimates, Turmeric (Dry) all India production for 2023 is at 5.26 lakh MT compared to last year's 4.67 lakh MT.

BLACK PEPPER

Fundamentals:

Today's Update:

- Steady sentiment was witnessed in Black pepper Delhi spot markets on Tuesday.
- Vietnam Pepper price as on last trade went sideways on a large scale in the domestic market. The current highest price is 69,500 VND/kg in Ba Ria Vung Tau province. Vietnam pepper prices in key provinces in the country are still steady in the range of 67,000 69,500 VND/kg. In which, Gia Lai and Dong Nai provinces are traded at 67,000 VND/kg. In Dak Lak and Dak Nong at 68,000 VND/kg, in Binh Phuoc and Ba Ria Vung Tau were stable at 69,000 VND/kg and 69,500 VND/kg respectively.
- Vietnam pepper prices have had an impressive increase in the context that the Chinese market continues to increase buying demand, along with demand from the US and EU markets.
- According to the preliminary data report of Vietnam Customs, pepper exports in the first 17 days of April 2023 reached 14,464 tons, bringing exports in more than three months. Current year to 89,795 tons, up 39.27% in volume and 8.59% in value over the same period in 2022. The average export price of pepper in the period was recorded at USD 3,048/ton, up 2.35% compared to the average export price of March 2023.
- During April 2023, Vietnam will be able to export 25,000-30,000 tons, bringing the total export volume from January to April 2023 to 102,000-107,000 tons, expected to be higher than the recorded 79,410 tons in the same period last year.

Previous Update:

• As per current situation, AgriWatch expects India's pepper production for 2022-23 likely to be around 52,000 to 53,000 MT. Last year production was 57,000 to 58,000 MT.

Today's Update:

- Firm sentiment was witnessed in Cumin cash markets on Tuesday.
- As anticipated, the export demand, particularly from China, has commenced and is being supported by good domestic demand, which is contributing to the higher price range in most of the cash markets.
- Continuous offloading of Cumin stocks by farmers and stockists due to the high demand in the market.
- AgriWatch predicts that the prices will continue to increase in the coming days due good demand.
- However, arrivals is expected to decrease in the long-term due to lower production in the current season.

Previous Update

• As per AgriWatch initial estimates, current year Cumin seed expected production would be around 3.03 lakh MT as compared to last year 3.16 lakh MT, down by 4.11%.

Fundamentals

Today's Update:

- Steady to weak sentiment was witnessed in Cardamom spot markets on Tuesday.
- The Kochi market has witnessed a decline in the prices of Small Cardamom Loose (Max. Price), traded at Rs. 1596 per kg, a decrease of 5.17% similarly Loose (Avg. Price) is being offered at a weaker rate of Rs. 1059 per kg, indicating a decline of 7.99% from the previous day's prices.
- Additionally, the total arrivals of Small Cardamom in the market reported down by 18,711 kgs at 21,368 kgs as compared to the previous day.

Previous Update:

- Agriwatch expects buyers to stay active in the spot market and support the prices.
- As per initial report AgriWatch estimates India's production for the marketing year 2022-23 is expected to be around 30,000 metric tonne (MT). Last year it was 27,000 MT.

- Farmers and stockists are releasing their stocks in anticipation of a further price decline due to higher production.
- However, stockists are taking advantage of the current low prices and have been purchasing 70% of the available stock, with an expectation of a price increase in the upcoming months.
- AgriWatch predicts that the prices will continue to remain steady within a narrow range, with slight downward
 corrections, as farmers are not selling their stocks in large quantities due to the relatively lower price range
 compared to the previous season.

Previous Update:

Current year Coriander seed production is expected to be around 5.22 lakh MT as compared to last year's 3.10 lakh MT, up by 68.39%.
