RED CHILLI

Spot Market Recap

- Mixed sentiment witnessed in Red Chilli spot market during December.
- Expected higher production in the coming marketing year is the main reason for lower demand at higher levels.
- At Guntur market new arrivals from Kurnool, Prakasham and Yemmiganur reported around 30,000 35,000 bags. As per trade information, 70-75% rain touch quality reported.
- In Byadgi, new chilli arrivals continued, however mostly with high moisture and rain touch quality. As per trade sources, 15 20% rain touch medium quality reported.
- Continued normal export demand reported from Vietnam, Malaysia and Indonesia at Guntur market, though the arrivals are lower of the Teja Deluxe variety.
- Currently, cold stores stocks continue to arrive at Guntur spot market at the rate of 57,500 bags (1 bag = 45kgs) per day from Guntur cold storages, where around 85,000 MT (and 108,000 MT in all of AP) stocks are still stored, compared to 55,000 MT last year.
- In Madhya Pradesh, new chilli crop continued at Bedia mandi around 1,500 to 1,600 (1 bag = 35 Kgs) on daily basis. As per trade sources, MP crop almost over up to January end weekly basis 1,800 to 2000 bags arrivals expected.
- We expect Chilli prices to correct from these levels in the spot market when good quality new arrivals enter to the market. We expect Chilli prices to correct Rs.500 1,000/-qtl from current levels during January, if no more untoward weather events take place.



Red Chilli Arrivals Scenario

From the 1st January 2020 to 31st Dec, red chilli supply in Guntur market is reported to add up to around 512,100 MT as compared to last year's 544,950 MT, down by 6.03% as most of the time, market was closed due to lockdown and farmers were slowly releasing their stocks an expectations of further higher prices.

Agriwatch Red Chilli Production Estimate 2021-22

Agriwatch first estimates, Red Chilli all India production for 2021-22 (marketing year) is estimated at 13.84 lakh MT. Last year's production was 12.32 lakh MT.





During December, Red chilli monthly average prices was Rs.13,714/-qtl, which was reported lower from November Rs.14,195/-qtl. Last year December it was Rs.14,495/-qtl.

Red Chilli Price Outlook

Chilli (NCDEX quality) in Guntur was traded at Rs.12,000 – 12,500 per quintal. Due to good domestic and export demand prices reported up. We expect prices (cold storage) to move in a range between Rs.10,000 – 11,800/-qtl in coming days.

Red Chilli Spot Price Outlook (Guntur, 334 variety)

Candlestick chart formation indicates prices may correct in the market. Red Chilli 334 variety prices are moving at Rs.12,500 – 13,300/-qtl. We expect prices (cold storage) to move in a range between Rs.10,800 – 12,000/-. in coming days.

TURMERIC

Spot Market Recap

- Continued mixed sentiment witnessed in Turmeric spot market during last month.
- Due to higher stocks in domestic markets, prices have not moved upwards as expected. Before March 2020, when the globalcovid-19 lockdowns began, all India ending stocks were expected to be 0.74 lakh MT for 2020-21 marketing period, but now it is estimated at 0.98 lakh MT due to lower domestic consumption and exports.
- Turmeric standing crop is reported to be fine in major growing regions in AP, Telangana, Tamil Nadu and Karnataka.
- Duggirala prices reported steady last week, however Kadapa prices reported up due to good quality supply.
- For 2021-22, Agriwatch estimate of Turmeric (Dry) production in Andhra Pradesh is around 43,523 MT (previous year it was 45,534 MT) and in Maharashtra Turmeric production would be around 62,809 MT(previous year it was 52,341MT). In Karnataka, production likely to be around 38,010 MT (previous year it was 32,098 MT).



In Nizamabad market during current year (2020), Turmeric arrivals are reported around 97,846 MT from 2nd January till 31st December compared to last year same period 109,515 MT, -10.66% down from last year.

In Erode spot market, turmeric supply is arriving at an average of 1,900 - 2,000 bags daily.

Agriwatch Turmeric Production Estimate 2021-22

Agriwatch first estimates, Turmeric all India production for 2021-22 (marketing year) is estimated at 4.46 lakh MT. Last year's production was 4.53 lakh MT.



Turmeric benchmark market during December average prices was Rs.5,725/-qtl slightly down from previous month Rs.5,800/- qtl, last year December it was Rs.6,005/-qtl. We expect buyers likely to active in the spot market from prevailing prices level.


Turmeric Price Outlook

Spot Market Recap


- Continued mixed sentiment witnessed in Coriander spot market during the last month.
- Continued lower supply reported in the spot market as farmers were holding back their produce at in the spot market.
- In Madhya Pradesh Guna, Neemuch and Mandsaur regions till date around 85 87% traded; rest of the produce is in farmer's hand. Rajasthan Kota, Ramganj, Baran, Bhawani-Jhalawar harvesting completed, 83 85% traded till now. Gujarat Gondal, Jamnagar, Porbandar harvesting completed, 85 87% traded till now.
- As per Agriwatch final production estimate, Coriander production for 2020-21 (marketing period) is estimated at 352,316 MT (88 lakh bags) compared to previous year's 268,957 MT (67 lakh bags, 1 bag = 40 kg).
- Coriander sowing continued in Rajasthan, Madhya Pradesh and Gujarat growing regions. As per trade information, area may go down in MP and Rajasthan, however in Gujarat sowing area reported higher.
- We expect 2021-22 marketing year likely to be good for Coriander.



Coriander total arrivals current year reported up by 7.54% from corresponding period last year as farmers and stockists were releasing their produce in the spot market before new crop supply.



During December at Kota spot market, lower arrivals reported from last month as farmers were holding their produce at current prices.

At Kota mandi, current year Coriander total supply from 2nd March to 31st December 13,392 MT as compared to last year 12,264 MT, up by 9.20%. In Kota during last season, from 12th March 2019 Coriander crop supply reported around 14,676 MT to 29th February 2020, compared to same period previous year it was 26,116 MT, down by 43.80%.

Current year coriander prices reported slightly correct from higher levels. During December monthly average price reported Rs.5,630/-qtl, previous month it was Rs.5,840/-qtl, last year December it was Rs.6,392/-qtl, down by 11.92%.

Agriwatch Coriander Price Outlook

Coriander Badami prices are expected to trade in a range of Rs.5,200 – Rs.5,700/- and Eagle variety is expected to increase to Rs.5,500 – Rs.6,000/-qtl.

Spot Market Recap

- Weak sentiment witnessed in Jeera spot market during last month.
- Lower supply reported as farmers were holding back their stocks at these prices.
- Jeera sowing finished in Gujarat and Rajasthan growing regions, current year area likely to go down by 15 – 20% due to lower prices.
- Jeera traded till now in Gujarat in major market like Unjha, Rajkot, Patan, Dhrol, Gondal around 85 – 87%.
- In Rajasthan Jodhpur, Nagaur- Harvesting has been completed, 86 88% traded, balance produce is in farmer's hand.
- In Unjha benchmark market new crop supply reported at around 1500 1600 bags on an average daily basis.
- We expect Jeera NCDEX quality prices to trade in a range between Rs.13,500 14,400/-qtl in coming days.




Jeera Arrivals Scenario

Last year total Jeera supply from 1st January 2019 to 31st December 2019, reported 160,282 mt as compared to same period last 174,559 mt, down by 8.18%.

In December 2020, Jeera monthly average prices reported at Rs.13,996/-qtl reported down from November, Rs.14,032/-qtl, as buyers reported inactive. Last year during December prices reported Rs.16,706/-qtl in spite of higher production Jeera prices moving at higher levels due to good export demand.

We expect Jeera NCDEX quality prices (monthly average) likely to trade range bound in coming days.

Agriwatch Jeera Production Estimate 2020-21 (Final)

As per Agriwatch final production estimate Jeera production for 2020-21 (marketing period) is estimated at 451,451 MT (around 82 lakh bags {1 bag = 55 kgs}) compared to previous year's 385,334 MT (70 lakh bags).

Spot Market Recap

- Firm sentiment witnessed in pepper spot market during December.
- Lower supply in the spot market supported the prices.
- As on 09th January, new pepper 500 G/L traded at Rs.31,600/-qtl, steady from previous day.
- As per trade sources, the total pepper output in the 2019-2020 crop year is estimated at 558,000 tons, still significantly higher than the total consumption demand of 496,000 tons.




Current year total Black pepper supply from 1st January 2020 to 31st December reported 5,261 mt as compared to last year same period 4,935 mt, up by 6.61%.

Last year, pepper supply reported from January to 30th December around 4,935 mt as compared to last year same period 3,814 mt, up by 29.39%.





Pepper supply reported down in Kochi spot market in December compared to previous month as planters were holding back their new crop due to cloudy weather, they were mostly picking immature pepper berry for pickle purpose.



During December 2020 at Kochi spot market pepper monthly average prices Rs.35,379/-qtl (Garbled) and Rs.33,379/-qtl (Ungarbled) reported, down by Garbled 1.66% and Ungarbled 1.77% from previous month as buyers reported active during December month.

International Scenario

Vietnam pepper prices leveled off in most surveyed locality. Provinces of Dak Lak, Dak Nong, Ba Ria - Vung Tau, Binh Phuoc and Dong Nai have stable purchases in the range of 52,000 - 54,000 VND / kg. Gia Lai alone adjusted to reduce 1,000 VND / kg compared to yesterday, recording the lowest transaction threshold of 51,000 VND / kg.

At the end of December 2020, export pepper prices in Brazil and Malaysia were stable compared to the end of November 2020. Meanwhile, India, Indonesia and China adjusted up again in the past month, the Import and Export Department reported.

Specifically, in Brazil, the price of black pepper for export was stable at USD 2,800 / ton. At the Malaysian port of Kuching, export prices for black and white pepper respectively recorded USD 3,675 / ton and USD 4,900 / ton respectively. In contrast, the price of black pepper at the port of Kochi (India) increased 1.2% (equivalent to 55 USD / ton) to 4,825 USD / ton. At the Indonesian port of Lampung ASTA, the price of black pepper at the end of December 2020 was 3,000 USD / ton, a sharp increase of 14.9% (equivalent to 388 USD / ton) compared to November 2020.

Similarly, at the port of Ha Khau (China), the price of white pepper for export on December 25, 2020 increased by 4.5% (equivalent to US \$ 225 / ton) compared to November 30, 2020, currently traded. around 5,275 USD / ton.

According to Malaysia Pepper Council (MPB), during 2020, domestic and global pepper prices tend to be unstable. Total pepper output in 2020 is estimated at 30,000 tons, down from nearly 4,000 tons compared to 33,940 tons in 2019.


Spot Market Recap

- Agriwatch estimates for 2020-21, India's Cardamom production would be around 22,000 23,000 MT, due to favourable weather conditions. Last year it was 19,000 – 20,000 MT.



During current marketing year (2020-21) Cardamom supply reported up due to increasing production. Cardamom supply during current season from August to December reported 7,881 tonnes higher by last year same period 4,260 tonnes.

During 2019-20 marketing year which was started from August 2019 to till July 2020 total Cardamom supply reported 8,225 MT as compared to last year same period 18,889 MT, down by 56.46% due to lower production amid lockdown situation.





Current marketing year starts from 1st August and December monthly average prices reported Rs.1,735/-kgs as compared to same period last year Rs.3,159/-kgs, down by 45.08% as buyers reported inactive due to higher production.

All India Cardamom monthly average prices for next month likely to move in a range between Rs.1,550–1,700/-kgs.
