

Pulses Domestic Fundamentals:

Today's Update:

- Rabi Urad sowing continued to gain momentum in all States including Tamil Nadu, AP. Urad coverage remained at 1.87 lakh ha., down by 6% from 1.99 lakh ha as on 18th November, 2022 same time last year. Coverage remained at 1.25 lakh ha, up by 8.7% from 1.14 lakh ha. in Tamil Nadu and at 0.40 lakh ha., up by 8% from 0.37 lakh ha. in AP.

Previous Update:

- Urad prices likely to trade steady to slightly weak on expected new crop arrivals from Chandausi line (UP) and Andhra Pradesh from next weekend onwards. In December small crop of Myanmar approx 25,000 tonnes will also come. In January-Feb Andhra big crop will come. From Feb end Myanmar new crop will start. Though India is currently facing shortage of Desi Urad but continuous supply of imported Urad will be able to fulfill the required demand of India. Urad prices may fall by INR 100-200 per quintal from current levels.

International Market Update:

- Myanmar C&F quotes slightly decreased to \$830 for FAQ from \$835 per MT and SQ variety quoted at previous level of \$970 per MT, basis Indian ports during the week.
