Today's Update

- As per data available from the Ministry of Commerce, India has imported 46,075 MT of Urad during the month of October 2022 as compared to 48,325 MT in September 2022. However, a quantity of 45,822 MT was imported during October 2021. Out of the total quantity imported during October 2022, around 45000 MT has been imported from Myanmar.
