

Pulses Domestic Fundamentals:

Today's Update

- C&F quotes for Myanmar FAQ and SQ varieties increased by \$5 for each variety to \$835 and \$935 per MT, basis Indian port on lower inventory and stock holding tendency by Myanmar traders in anticipation of higher demand from India. Urad prices too likely to be supportive in coming days on increased festival & marriage season demand and higher C&F quotation over holding back tendency among Myanmar traders as timeline for Urad import has also been extended till next year March 2024.

Previous Update:

- C&F quotes for Myanmar FAQ and SQ varieties decreased by \$15 to \$830 and \$930 per MT, basis Indian port due to profit booking at higher levels after recent hike on lower inventory and stock holding tendency by Myanmar traders in anticipation of higher demand from India. Urad prices are likely to remain supportive in the coming week. However, any Govt. intervention may have negative impact on the sentiment.

International Market Update:

- C&F quotes also supported the sentiments. Quotes for FAQ and SQ varieties increased by \$15 and \$20 per MT to \$850 per MT and to \$955 per MT, basis Indian ports respectively.
