

Urad Domestic Fundamentals:

Today's Update

- Govt.'s warning of stern action against the rising prices of two major imported Pulses Tur and Urad is likely to have a temporary impact on prices right now. However, given the background of lower stocks at ports, any steep and sudden fall in prices is unlikely as of now. Price direction in the domestic market would depend on import volume coming into India from Myanmar. If, the competent authorities succeed in creating pressure on the traders who have reportedly stocked in Myanmar to export it to India, it may bring down the prices by INR 300-400 per quintal in coming days, otherwise, prices may start moving up again after a slight downward correction.

Previous Update:

- Urad new fresh arrivals started in Jabalpur market and traded at INR 7500-8800 per qtl. with 700 bags of arrivals.
- Urad traded firm due to limited stock at port and increase in import disparity by INR 400-500 per qtl. C&F quotes increased by \$25 for both Urad FAQ and SQ to \$980 and \$1080 respectively.

International Market Update:

- C&F quotes from Myanmar for Urad FAQ and SQ decreased by \$5 for each to \$975 and \$1075 per MT, basis India port.
