

Urad Domestic Fundamentals:

Today's Update

- C&F quotes for Urad FAQ and SQ varieties increased by \$5 to \$1015 and \$1115 per MT, basis Indian port, respectively due to good demand amidst tight supply and lower intention to sell out their stocks by local traders in Myanmar. Urad prices are likely to trade steady to slightly firm despite the new summer crop arrivals which remains small in size.

Previous Update:

- Urad traded down by INR 500 to INR 8000 per quintal in Indore due to increased local crop arrivals amidst steady C&F offers which remained flat at \$1010 per MT, basis Indian port. At present, domestic demand has shifted to summer crop supplies. However, the overall trend is up and prices again likely to move up as summer supplies are limited.

International Market Update:

- C&F quotes from Myanmar for Urad FAQ and SQ increased by \$35 and \$5 to \$1015 and \$1115 per MT, basis India port.
