

Urad Domestic Fundamentals:
Today's Update:

- Urad experienced a decline of 1-2% on average, mainly due to the release of stocks by stockists and traders, coinciding with an increase in sowing activities across India. Urad FAQ traded at INR 8125 per quintal, down by 0.61% in Mumbai and at INR 8025 per quintal, down by 0.62% in Chennai.

Previous Update:

- According to the recent release by Department of Agriculture & Farmers Welfare, farmers have covered 18.154 lakh ha. area under Kharif pulses as on 30th June 2023, down by 1.9% from 18.507 lakh ha. same time last year. Urad has been sown in 1.726 lakh ha, up by 6.94% from 1.61 lakh ha., Moong in 11.235 lakh ha., up by 28.64% from 8.734 lakh ha. and Tur in 0.18 lakh ha., down by 65% from 1.79 lakh ha. same time last year.

International Market Update:

- C&F quotes from Myanmar for Urad FAQ and SQ varieties are increased by \$45 each at \$1055 and \$1155 per MT, basis India port.
