

Domestic Fundamentals:

- Major edible oils markets were steady to slightly firm due to gains in the international palm oil market. While, need based demand witnessed in the cash market.
- Indian Government has revised the tariff value for crude palm oil to US \$ 877, RBD palm oil to US \$897, Crude and
 refined palmolein to 899, 902 (US dollar per metric tons) respectively. Moreover, USD 944 per tons sets as a new base
 import price for crude soybean oil.
- Groundnut oil featured steady tone at major cash market owing to good supplies against average demand. Most of the
 raw material consumed by oil millers, while weak export demand for groundnut seed noticed. Groundnut oil quoted Rs
 800 per 10 Kg at Rajkot market.
- Soy oil featured steady to slightly firm tone at major cash market tracking gains in the international oil & fats market and renewed demand at lower quotes. Soybean oil quoted Rs 660 per 10 Kg, unchanged from Wednesday.
- Edible oil basket is expected to feature steady tone in the near-term. While, recovery in the Indian rupee and sideways trend in the international oil and fats market may cap the gains.

International Market Fundamentals:

- CPO at BMD futures market ended higher on good demand for US soybean from China and weak ringgits against USD dollar.
- China is likely to imports 46.1 lakh tons of soybeans in January Ministry. Exports of Malaysian palm oil products for Jan 1-15 fell 28 percent to 460,248 tons, from the last corresponding period of the last year - cargo surveyor Intertek Testing Services.

Outlook: Edible oil basket is expected to feature steady tone in the near-term.
