

Domestic Fundamentals:

- Edible oils basket featured firm tone in the major cash markets. Palm, mustard and coconut oil edged higher, Thursday.
- Mustard oil featured steady to slightly firm tone at Kota market tracking gains in the oil complex and renewed demand from oil millers. Mustard oil at Kota market quoted Rs 665 per 10 Kg, up Rs per 5 per 10 Kg from previous trading session.
- Refined soybean oil featured gains tracking firm trend in the international oil & fats market. However, need based demand in the cash market, rising mustard seed supplies limit the excessive gains. Ministry of Agriculture lowers its soybean output projections for 2013/14 to 12.45 million tons. While, last year India's soybean production was at 12.21 million tons.
- Edible oil basket is expected to feature steady to firm tone in the near-term. While, higher soybean output projections and sideways trend in the international oil and fats market may cap the gains.

International Market Fundamentals:

- Exports from Malaysia rose 17 per cent to 875,091 tons in the first 20 days of Feb. from the same period of last month -Intertek.
- As per Safras & Mercado, Brazilian farmers have harvested 21 percent of the soybean estimated acreage as of 14
 Feb., 2014, up 8 percent from last week. However, last year at the same period farmers had harvested 15
 percent. AgRural lowered Brazil's soybean projections to 87 million tons for 2014, down one million tons from the
 previous estimates.

Outlook: Edible oil basket is expected to feature steady to slightly firm tone on moderate buying in the near-term.
