

#### **Domestic Fundamentals:**

- Most of the edible oils featured steady to weak tone at different market centers owing to limited buying and weak cues from the international palm oil market, Thursday.
- Crude palm oil featured weak tone in line with the overseas market and lackluster buying. Crude palm oil at Kandla quoted Rs 560 per 10 Kg, down Rs 5 per 10 Kg from Wednesday's trade session.
- Sunflower oil featured steady to slightly weak tone at major cash market due to lackluster buying, correction in the Ukraine's sun oil prices. As per sources, Indian buyers had imported in between 0.35-0.45 lakh tons during the first 25 days of March. India is likely to purchase 1.45 million tons sunflower oil in 2013/14 - Ruchi Soya.
- Edible oil basket is expected to feature steady tone in the near-term. While, higher soybean output projections from last year and consolidation in the international oil and fats market may cap the gains.

#### International Market Fundamentals:

- CPO at BMD ended lower owing to weak Malaysian palm oil exports for 1-25 March and correction in the oversea oil/fats market. However, lower palm oil production forecast for March limits the excessive gains.
- South America's top five producing countries soybean production forecast at 151.45 million tons in the 2013-14 season, 0.85 million tons higher from the February estimate. Moreover, Brazil and Argentina soybean production estimate for 2013/14 at 84.5 million and 53.5 million tons respectively - Oil World.

Outlook: Edible oil basket is expected to feature steady tone in the near-term.
